OPEN MEETING - WEDNESDAY, MAY 11, 1988 - 1:00 p.m.

The subject matter of the May 11 open meeting will be:

Consideration of whether to issue a Memorandum Opinion and Order with respect to an application declaration filed by Eastern Utilities Associates (EUA), a registered holding company under the Public Utility Holding Company Act of 1935, and its subsidiary, EUA Power Corporation. EUA Power proposes to: (1) issue up to \$180 million of 17-1/2% Series B Secured Notes, due 1993, only in exchange for up to \$180 million of 17-1/2% Series A Secured Notes, now outstanding, and up to 180,000 Contingent Interest Certificates (CICs), one of which will be issued with each \$1,000 principal amount of Series B Notes in exchange for Series A Notes; (2) issue up to \$100 million of 17-1/2% Series C Notes to the Series B Noteholders and the Series C Noteholders in lieu of the payment of cash interest on the Series B and Series C Notes; and (3) issue and sell up to \$25 million additional shares of Preferred Stock to EUA. EUA proposes to acquire EUA Power's Preferred Stock and, in connection therewith, to issue \$25 million of short-term notes under its existing bank lines of credit. Consideration will also be given to whether to issue an order for a hearing in response to a request for a hearing pending in this matter. FOR FURTHER INFORMATION, PLEASE CONTACT Robert P. COMMISSION ANNOUNCEMENTS

FRIEND-OF-THE-COURT BRIEF FILED CHALLENGING WISCONSIN TAKEOVER LAW AS UNCONSTITUTIONAL

The Commission yesterday filed a friend-of-the-court brief in the U.S. District Court for the Eastern District of Wisconsin in RTE Corp. v. Mark IV Industries, Inc. In that case Mark IV, which has made a tender offer for RTE stock, contends that a Wisconsin law regulating takeover bids is unconstitutional. The Commission's brief agrees that the Wisconsin law is unconstitutional. (Press Release 88-41)

NEW TELEPHONE SYSTEM FOR CHIEF COUNSEL'S OFFICE IN INVESTMENT MANAGEMENT

On May 9, the Chief Counsel's Office of the Division of Investment Management will institute a system for processing all incoming telephone calls through the use of answering machines. Callers will be asked to leave their name, telephone number, and a brief statement regarding the nature of their call. ADMINISTRATIVE PROCEEDINGS

APPEAL OF AMERICAN INVESTORS OF PITTSBURGH, INC. AND ITS PRINCIPALS DISMISSED AS MOOT

The Commission dismissed as moot an appeal from NASD action by the brokerage firm of American Investors of Pittsburgh, Inc. and its three principals, John J. Bruno, John W. Mendicino, and Charles Krzywicki. The firm and its principals were convicted of conspiracy to defraud the United States by concealing currency transactions of customers and clients. On the basis of the convictions, the NASD cancelled the firm's membership and suspended its principals' registrations with the firm. In dismissing the appeal as moot, the Commission noted that American Investors has ceased operation, begun the process of self-liquidation, and filed on application to withdraw its broker-dealer registration. CIVIL PROCEEDINGS

JAMES SIMPSON, OTHERS TEMPORARILY RESTRAINED

The Chicago Regional Office announced that on April 25 Judge Rudy Lozano, Northern District of Indiana, entered a Temporary Restraining Order against James Simpson, Richard Holiusa, Donald Swanson, Certified Investment Companies, Certified Commodities, Inc., Certified Precious Metals, Inc., and Levitan Investment Management Corp. The Order temporarily enjoins the defendants from violating the antifraud and registration provisions of the securities laws, freezes all of their assets, and requires them to provide an accounting to the court.

The Complaint alleges that defendants: (1) engaged, from at least 1983, in a fraudulent scheme in connection with the offer and sale of securities in the form of investment contracts; (2) raised at least \$3.2 million from 180 investors nationwide; (3) told investors that their investment monies would be used to purchase large quantities of silver and government securities (in fact, no silver or government securities were purchased); and made other material misrepresentations and omissions concerning, among other things, returns to be expected and the risks associated with the investment. The Court held a hearing for a preliminary injunction on May 5. (SEC v. James Simpson, et al., NDIN, Civil Action No. H88-0212). (LR-11725)

COURT SETS JUNE 1 HEARING DATE FOR CONTEMPT MOTION AGAINST ROBERT A. DIIANNI

The Boston Regional Office announced that on May 2 the U.S. District Court for the District of Massachusetts (Judge A. David Mazzone) granted the Commission's April 25 motion and issued an Order to Show Cause requiring Robert A. Dilanni of Boston to file, within ten days, a statement of all objections and any legal support therefor, as to why he should not be adjudged in civil contempt for failing to comply with the Court's Order of Disgorgement entered on April 13. The Commission asked the Court to adjudge Dilanni in civil contempt and to order him placed in the custody of the U.S. Marshal until such time as he complies. The Court scheduled a Show Cause hearing for June 1.

The Order of Disgorgement required Dilanni to disgorge to the Court \$3,719,990 by April 25. Instead, Dilanni stated his intention not to comply, asserting that the Order of Disgorgement compels him to testify against himself in violation of his rights and privileges under the Fifth Amendment to the U.S. Constitution. (SEC v. Robert A. Dilanni, DCMA, Civil Action No. 87-1891-MA). (LR-11726)

INVESTMENT COMPANY ACT RELEASES

KIDDER, PEABODY ACCEPTANCE CORPORATION I

A notice has been issued giving interested persons until May 27 to request a hearing on an application by Kidder, Peabody Acceptance Corporation I for an order exempting it from all provisions of the Investment Company Act. The requested order would permit the sale of certain beneficial interests in any trust (as defined in the application) to certain "accredited investors," as redefinied in Rule 501(a) of the Securities Act of 1933, as amended, and in the application. FIDELITY CAPITAL TRUST

A notice has been issued giving interested persons until May 30 to request a hearing on an application filed by Fidelity Capital Trust and certain other funds and Fidelity Brokerage Services, Inc. (FBS), for an order permitting the Funds to lend their portfolio securities to FBS. (Rel. IC-16390 - May 5)

HOLDING COMPANY ACT RELEASES

KENTUCKY POWER COMPANY

An order has been authorizing Kentucky Power Company, subsidiary of American Electric Power Company, to issue and sell up to \$75 million of long-term unsecured promissory notes under a term-loan agreement. (Rel. 35-24637 - May 4)

UNLISTED TRADING SOUGHT

Notices have been issued giving interested persons until May 24 to comment on the application of the following stock exchanges for unlisted trading privileges in the specified number of issues which are listed and registered on one or more other national securities exchanges and are reported in the consolidated transaction reporting system: Midwest Stock Exchange - four and three issues [two separate applications]. SELF-REGULATORY ORGANIZATIONS

APPROVAL OF PROPOSED RULE CHANGES

The Commission approved proposed rule changes filed by: Philadelphia Stock Exchange (SR-Phlx-88-6) to amend its position limits rule to establish a maximum of 25,000 contracts for the Value Line Composite Index, and 10,000 contracts for the National Over-the-Counter Index. (Rel. 34-25644); (SR-Phlx-87-38) that would establish a general policy of granting allocation priority to existing specialist units for the securities and options for which they act as specialist in additional trading sessions or for any new type of an existing option that is listed for allocation. (Rel. 34-25647); and the National Association of Securities Dealers (SR-NASD-87-43) that amends the Resolution of its Board of Governors concerning Notice to Membership and Press of Suspensions, Expulsions, Revocations, and Monetary Sanctions. The amendment gives the Board of Governors discretion in extraordinary circumstances to waive publication of disciplinary actions involving imposition of monetary sanctions of \$10,000 or more. (Rel. 34-25652)

The American Stock Exchange filed a proposed rule change under Rule 19b-4 (SR-Amex-88-7) that would extend its Rule 126(g) precedence based on size pilot program until November 1 and change the size of blocks eligible for precedence under the pilot to 25,000 shares from the current level of 50,000 shares. The Commission granted accelerated approval to an extention of the Amex pilot until November 1 at its current level for blocks of 50,000 shares of more. (Rel. 34-25653)

TRUST INDENTURE ACT RELEASES

NORSTAR BANCORP INC.

A notice has been issued giving interested persons until May 31 to request a hearing on an application by Norstar Bancorp, Inc., a New York corporation, under Section 310 (b)(1)(ii) of the Trust Indenture Act of 1939. The application declares that the trusteeship of Chemical Bank under two Norstar indentures is not so likely to involve a material conflict of interest as to make it necessary in the public interest or for the protection of investors to disqualify the Bank from acting as trustee under each such indenture. The indentures are dated January 11, 1982 and January 1, 1985 and the securities outstanding under them are approximately \$2 milion of 10%, due 1992, and \$100 million floating rate subordinated capital notes, due 1997, respectively.
