CIVIL PROCEEDINGS

U.S. SECURITIES AND EXCHANGE COMMISSION

COMPLAINT NAMES KIRK A. KNAPP

The Chicago Regional Office filed a Complaint on May 12 in the U.S. District Court for the Western District of Michigan, Southern Division, seeking Orders of Preliminary and Permanent Injunction against Kirk A. Knapp, enjoining him from further violations of Article II, Section 3(b) of the By-Laws of the National Association of Securities Dealers, Inc. and certain of the antifraud and antimanipulation provisions of the securities laws.

The Complaint alleges that Knapp has associated with an NASD member, K.A. Knapp & Co., Inc., while not qualified to so associate by participating in Knapp & Co.'s investment banking or underwriting activities. The Complaint also alleges that in connection with Knapp & Co.'s underwriting of the September 1987 initial public offering by Centrac Associates, Inc., Knapp induced Knapp & Co. to bid for and purchase Centrac's stock before the public distribution was complete and that Knapp, in connection with the offer, purchase, and sale of Centrac's stock, made misrepresentations and omissions concerning Centrac's receipt of \$1.01 million of the net proceeds of its September 1987 initial public offering and Centrac's use of the proceeds from that offering.
