## **INVESTMENT COMPANY ACT RELEASES**

NEW ENGLAND MUTUAL LIFE INSURANCE COMPANY

An order has been issued exempting New England Mutual Life Insurance Company, the New England Variable Account, and New England Securities Corporation from the provisions of Sections 26(a)(2)(C) and 27(c)(2) of the Investment Company Act to permit the deduction of mortality and expense risk charges from the assets of the Account. ### HOLDING COMPANY ACT RELEASES

SYSTEM ENERGY RESOURCES, INC.

A supplemental order has been issued authorizing System Energy Resources, Inc. (SERI), subsidiary of Middle South Utilities, Inc., to extend, from August 31, 1988 to February 28, 1989, its Restated and Amended Fuel Lease with Port Gibson Energy, Inc. under which SERI leases from Port Gibson the nuclear fuel used to satisfy a portion of the fuel requirements of Unit No. 1 at SERI's Grand Gulf Nuclear Generating Station. In addition, SERI will acknowledge notice and consent to Port Gibson entering into an Amendment to the Restated and Amended Credit Agreement with many banks which will extend its expiration date to February 29, 1989 and which consent is required by the Fuel Lease. ## SELF-REGULATORY ORGANIZATIONS

ORDER GRANTING ACCELERATED TEMPORARY APPROVAL OF PROPOSED RULE CHANGE

The Depository Trust Company filed a proposed rule change under Rule 19b-4. The proposal (SR-DTC-88-16) is to obtain authorization for a pilot program for its new memo segregation service, designed to assist broker-dealer participants in protecting customer securities against unintended delivery and in complying with Commission Rule 15c3-3. The Commission is publishing this notice to solicit comment on the rule change and to grant temporary approval for 60 days. (Rel. 34-26000)

#### NOTICE OF PROPOSED RULE CHANGE

The New York Stock Exchange filed a proposed rule change under Rule 19b-4 (SR-NYSE-88-21) to amend its Rule 750 and to adopt, on a two-year pilot basis, a new rule (NYSE Rule 750A) that establishes guidelines for the evaluation of options specialist performance and for the reallocation of option classes and products due to substandard options specialist performance. Publication of the proposal is expected to be made in the <u>Federal Register</u> during the week of August 22. (Rel. 34-26001)

### APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change filed by: The National Association of Securities Dealers (SR-NASD-88-25) which amends Sections 5(c) and 6 of Article V, Part A of its Code of Procedure to clarify that District Surveillance Committee action taken under Article V, Part A, Section 5(c) constitutes final action of the NASD which is reviewable by the SEC in contract to written decisions issued under Sections 5(a) and (b) of Article V, Part A.
