U.S. SECURITIES AND EXOLUNGE COMMISSION

RULE 10b-21(T) ADOPTED

The Commission adopted, on a temporary basis, Rule 10b-21(T) under the Securities Exchange Act of 1934. Rule 10b-21(T) prohibits a person who effects short sales of an equity security during the period beginning at the time that a registration statement or Form 1-A relating to the same class of equity securities is filed and ending at the time that sales may be made in the offering, from covering such short sales with offered securities purchased from an underwriter or broker or dealer participating in the offering of such securities. COMMISSION ANNOUNCEMENTS

STAFF ACCOUNTING BULLETIN ON QUASI-REORGANIZATIONS

The staff released Staff Accounting Bulletin (SAB) No. 78, which addresses certain matters relating to accounting for quasi-reorganizations. The SAB states the staff's position that (1) elimination of accumulated deficits by reclassifying amounts from paid-in capital without satisfying all the conditions set forth in Section 210 of the Commission's Codification of Financial Reportiong Policies is prohibited; (2) anticipated accounting changes should be adopted prior to or as an integral part of the quasi-reoganization; and (3) there may not be a write-up of net assets in connection with a quasi-reoganization. CIVIL PROCEEDINGS

INJUNCTIONS ENTERED AGAINST GOLDCOR, INC., OTHERS

The Atlanta Regional and Miami Branch Offices announced that on July 27 U.S. District Judge G. Kendall Sharp, Middle District of Florida, entered a Final Judgment of Permanent Injunction against Goldcor, Inc. and Judgments of Preliminary Injunction against Carl W. Martin, Richard D. Brown, and Nitram Corporation. The Judgments enjoin defendants from violations of the registration and antifraud provisions of the securities laws and continue a previously ordered freeze of their assets. Defendants consented to the Judgments without admitting or denying the allegations of the Complaint.

The July 15 Complaint alleges that Nitram, Brown, and Martin engaged in a distribution of unregistered Goldcor common stock into the over-the-counter market, generating proceeds of at least \$13 million. It further alleges that defendants, by various news releases and other statements, falsely represented that Goldcor was actively engaged in refining gold from the beaches of Costa Rica. (SEC. v. Goldcor, Inc., et al., Civil Action No. 88-612-CIV-ORL-18, MDFL). (LR-11847)

INVESTMENT COMPANY ACT RELEASES

BARCLAYS BANK PLC

An order has been issued exempting Barclays Bank PLC, an English bank, and any registered investment company or custodian for such investment companies from the provisions of Sections 17(f) of Investment Company Act to permit Barclays and such investment companies and custodians to maintain securities in the custody of certain foreign subsidiaries of Barclays.
