COMMISSION ANNOUNCEMENTS

DISCONTINUANCE OF SEC MONTHLY STATISTICAL REVIEW

The Commission has determined to discontinue publication of its Monthly Statistical Review. The last issue will be published in February 1989. Furthermore, the collection of data for the Registrations and Offerings Statistics File will be discontinued as of December 31, 1988. We regret any inconveninence this decision may cause.

CIVIL PROCEEDINGS

RECEIVER APPOINTED FOR GOLDCOR, INC.

The Atlanta Regional and Miami Branch Offices announced that on October 4 U.S. District Judge G. Kendall Sharp, Middle District of Florida, granted the Commission's motion for the appointment of a receiver for Goldcor, Inc. Goldcor had previously filed a motion to lift the freeze of its assets in order to proceed with its business plans, which motion the Court denied. The Court appointed D. Jack Powell, Jr., CPA, of Orlando, Florida, as receiver.

The July 15 Complaint alleges that Richard D. Brown, Carl W. Martin, and Nitram Corp. engaged in a distribution of unregistered Goldcor common stock into the over-the-counter market, generating proceeds of at least \$13 million. It further alleges that defendants, by various news releases and other statements, falsely represented that Goldcor was actively engaged in refining gold from the beaches of Costa Rica. (SEC v. Goldcor, Inc., et al., Civil Action No. 88-612-CIV-ORL-18, MDFL). (LR-11900)

INVESTMENT COMPANY ACT RELEASES

MIDLANTIC FUNDING COPORATION

A notice has been issued giving interested persons until November 15 to request a hearing on an application filed by Midlantic Funding Corporation for an order exempting it from all provisions of the Investment Company Act so that it may sell certain debt instruments and non-voting preferred stock and utilize the proceeds to finance the activities of its sole shareholder, a bank holding company, and certain companies controlled by its sole shareholder. Penney Company, Inc. the unrelated distribution facilities serving the JC Penney Catalog Distribution Center located in Forest Park, Georgia, for an aggregate price of \$1,224,044.57.

SIGNIFICANT NO-ACTION AND INTERPRETIVE LETTERS

The following is a list of significant no-action and interpretative letters recently issued by the Divisions of Investment Management and Corporation Finance. These letters express the view of the Division respecting novel or important questions arising under the Securities Act of 1933, the Securities Exchange Act of 1934, the Trust Indenture Act of 1939, the Investment Company Act of 1940, and the Investment Advisers Act of 1940.
