RULES AND RELATED MATTERS

APPROVAL OF AMENDMENT TO RULE 3a12-8

The Commission adopted an amendment to Rule 3a12-8 under the Securities Exchange Act of 1934. The amendment will designate as exempted securities, solely for purposes of the trading and marketing in the U.S. of futures contracts on those securities, debt securities issued by the governments of Austria, Denmark, Finland, the Netherlands, Switzerland, and West Germany. Rule 3a12-8 currently provides such an exemption for British, Canadian, Japanese, Australian, French, and New Zealand debt securities underlying futures contracts that meet certain conditions set forth in the Rule. The amendment will be effective upon publication in the Federal Register. (Rel. 34-26217)

CRIMINAL PROCEEDINGS

JAMES ATTARIAN, OTHERS SENTENCED

The Los Angeles Regional Office and the U.S. Attorney's Office for the Eastern District of California announced that on October 18 District Judge Lawrence K. Karlton sentenced James Attarian to eight years in prison and five years probation. On October 12, Judge Karlton sentenced Russell Smith to five years in prison and five years probation and Donald Smith to four years in prison and five years probation. On September 20, Judge Karlton sentenced Richard Plache to four years in prison and five years probation and Gordon De Leon to 30 months in prison and five years probation. Attarian and Plache were convicted, and R. Smith, D. Smith, and De Leon pled guilty, to various counts of mail fraud and selling unregistered securities in connection with the purchase and sale of the securities of Elmas Mining Corporation and Republic Overseas Bank, Ltd. which purported to engage in low risk arbitrage trading and the operation of a gold mine.
