## **RULES AND RELATED MATTERS**

RULE 6C-10 AND AMENDMENTS TO FORM N-1A PROPOSED FOR COMMENT

> The Commission is proposing for public comment Rule 6c-10 under the Investment Company Act of 1940 and amendments to Form N-1A under the Securities Act of 1933. Rule 6c-10would provide a registered open-end management investment company, other than a registered insurance company separate account (fund), and certain related persons, with exemptions from the Act to permit the fund to impose sales loads on a deferred basis. The amendments to Form N-1A, the registration statement for funds, would modify that form to accommodate the deferred sales loads that would be permitted if Rule 6c-10 is adopted.

## TRADING SUSPENSIONS

TRADING SUSPENDED IN THE SECURITIES OF AMERICAN BRITISH ENTERPRISES, INC.

The Commission announced the temporary suspension of over-the-counter trading in the securities of American British Enterprises, Inc., a Utah corporation, for the ten-day period beginning at 9:00 a.m. (EST) on November 3 and terminating at 11:59 p.m. (EST) on November 12.

The Commission temporarily suspended trading in the securities of American British because of a lack of current information about the issuer and in view of questions that have been raised about the adequacy and accuracy of publicly disseminated information concerning the location of its principal offices, the identity and background of its officers and affiliates, its financial condition, and the nature and extent of its current and proposed business activities. ## **INVESTMENT COMPANY ACT RELEASES**

RBSG CAPITAL CORPORATION

A notice has been issued giving interested persons until November 25 to request a hearing on an application filed by RBSG Capital Corporation for an order exempting it from all provisions of the Investment Company Act to permit it to issue and sell its debt securities in the United States. #### HOLDING COMPANY ACT RELEASES

NORTHEAST UTILITIES; ALLEGHENY GENERATING COMPANY

Notices have been issued giving interested persons until November 21 to request a hearing on a proposal by the following companies filed under Release 35-24736, dated October 27: NORTHEAST UTILITIES (NU) - a registered holding company, to form Charter Oak Energy, Inc. (Energy), a subsidiary, to engage in the investment and participation in qualifying cogeneration facilities and in qualifying small power production facilities (collectively, Qualifying Facilities). Northeast and Energy propose for Energy to issue and Northeast to acquire 100 shares of Energy common stock for \$10,000. It is further proposed through December 31, 1992 that Northeast invest up to \$200 million in Energy in the form of common stock, capital contributions, open account advances, loans and guarantees, and Energy invest in Qualifying Facilities directly or indirectly through joint ventures or special purpose companies up to a total of \$200 million; and <u>ALLEGHENY GENERATING COMPANY</u> - subsidiary of Allegheny Power System, to issue mediumter notes in an aggregate principal amount not to exceed \$150 million.

# **SELF-REGULATORY ORGANIZATIONS**

TEMPORARY ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The MBS Clearing Corporation filed a proposed rule change which became temporarily effective. The proposal (SR-MBS-88-15) would impose a schedule of penalties for MBSCC Depository Division participants who fail to make timely payment of their debit balances. (Rel. 34-26226)

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission granted accelerated approval to a proposed rule change filed by the Chicago Board Options Exchange (SR-CBOE-88-18) requiring member firms to submit certain customer and proprietary trading information in an automated format. (Rel. 34-26235)

EFFECTIVENESS OF PROPOSED RULE CHANGE

The Midwest Stock Exchange filed a proposed rule change which became effective immediately upon filing under Section 19(b)(3)(A) of the Securities Exchange Act of 1934 (SR-MSE-88-10) to decrease the filing fees for electronically submitted extension requests. (Rel. 34-26236)

TEMPORARY APPROVAL OF PROPOSED RULE CHANGE

The Commission temporarily approved until December 31 three proposed rule changes filed by The MBS Clearing Corporation (SR-MBS-88-7, MBS-88-9, MBS-88-11) to amend and clarify various provisions of MBSCC's Depository Division rules. (Rel. 34-26237)
