U.S. SECURITIES AND

EXCHANCE COMMISSION

ADMINISTRATIVE PROCEEDINGS

IRWIN N. SCHNEIDER BARRED

The Commission instituted an administrative proceeding under Rule 2(e) of its Rules of Fair Practice and entered an Order Making Findings and Imposing Remedial Sanctions against Irwin N. Schneider. Schneider, while neither admitting nor denying the findings made therein, consented to the Order. The Commission found, among other things, that Schneider was convicted by the U.S. District Court for the Southern District of New York of one count of securities fraud and sentenced to two years in prison and fined \$10,000. In its Order, the Commission permanently barred Schneider from appear-ing or practicing before the Commission as an attorney. (Rel. 34-26224)

CIVIL PROCEEDINGS

COMPLAINT NAMES TED K. SCHWARZROCK

The Commission filed an action on November 2 in the U.S. District Court for the District of Minnesota against Ted K. Schwarzrock alleging that he violated certain antifraud provisions of the securities laws. The Complaint alleges that Schwarzrock, while vice president of Sales and Marketing of Aeguitron Medical Inc., sold Aeguitron stock while in possession of material, non-public information concerning Aequitron's sales and anticipated net loss for its third quarter ending January 31, 1987. Simultaneous with the filing of the Complaint, Schwarzrock, without admitting or denying the allegations, consented to a permanent injunction against future violations of the antifraud provisions, disgorgement of \$26,070.00, representing his losses avoided and a civil penalty of \$26,070.00. (SEC v. Ted R. Schwarzrock, USDC DMN, Civil Action No. 3-88-728), (LR-11906)

INVESTMENT COMPANY ACT RELEASES

NORTH AMERICAN LIFE AND CASUALTY COMPANY
