HOLDING COMPANY ACT RELEASES

APPALACHIAN POWER COMPANY

A supplemental order has been issued authorizing Appalachian Power Company, subsidiary of American Electric Power Company, to alter the terms and conditions of installment payments for pollution control facilities, under an agreement that Appalachian has with the Industrial Development Authority of Russell County, Virginia (Authority), to reflect the terms of pollution control revenue bonds to be issued by the Authority. (Rel. 35-24737 - Oct. 31)

GENERAL PUBLIC UTILITIES CORPORATION

An order has been issued authorizing General Public Utilities Corporation (GPU), a registered holding company, to acquire a new subsidiary, General Portfolios Corporation (GPC), by acquiring its common stock for the sum of \$100,000 and to make contributions to the capital of GPC of (a) the common stock of Energy Initiatives, Incorporated (EII), subsidiary of Jersey Central Power & Light Company, and (b) \$50 million, \$25 million of which GPC will in turn contriution to the capital of EII through December 31, 1989 and \$25 million over which the Commission has been requested to reserve jurisdiction. ALLEGHENY POWER SERVICE CORPORATION

An order has been issued authorizing Allegheny Power Service Corporation, The Potomac Edison Company, and Allegheny Generating Company, direct and indirect subsidiaries of Allegheny Power System, Inc., to amend their respective Charters regarding the liability of their officers and directors. NOTICE OF PROPOSED RULE CHANGES

A proposed rule change has been filed under Rule 19b-4 by: <u>The National Association</u> of <u>Securities Dealers</u> (SR-NASD-88-29) to add and amend specific provisions of its Code of Arbitration Procedure to improve the efficiency of its arbitration process. (Rel. 34-26242); and <u>The American Stock Exchange</u> (SR-Amex-88-23) that would amend its Rule 205 to revise its odd-lot pricing and execution procedures. (Rel. 34-26246)

Publication of the proposals are expected to be made in the <u>Federal Register</u> during the week of November 7.

EFFECTIVENESS OF PROPOSED RULE CHANGE

The Boston Stock Exchange and the Boston Stock Exchange Clearing Corporation have proposed an amendment to their schedules of value and comparison charges. The proposed amendment (SR-BSE-80-3) would reduce charges on trades of less than 1,300 shares. The proposed amendment is a fee change and therefore has become effective upon filing under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. (Rel. 34-26247)
