U.S. COMMISSION

DANIEL B. PTAK BARRED

The Commission instituted public administrative proceedings under the Securities Exchange Act of 1934 against Daniel B. Ptak, a former registered representative of Protective Equity Services, Inc., a broker-dealer registered with the Commission, with offices in Birmingham, Alabama. Simultaneously, the Commission accepted Ptak's Offer of Settlement.

The Commission found that between November 1986 to about May 4, 1987, Ptak wilfully violated the antifraud provisions of the securities laws by falsely stating to investors that their funds would be used to purchase shares in various mutual funds, when in fact Ptak was misappropriating the funds. The Commission also found that a Final Judgment of Permanent Injunction was entered against Ptak for violating the antifraud provisions [SEC v. Ptak, Case No. 88-6444-CIV-MARCUS, SDFL]. The Order provides that Ptak be barred from association with any broker, dealer, municipal securities dealer, investment adviser, or investment company.

In his Offer of Settlement, Ptak consented to the Order without admitting or denying the allegations except that he admitted that a Final Judgment of Permanent Injunction was entered against him, enjoining him from violating the antifraud provisions. (Rel. 34-26239)

INVESTMENT COMPANY ACT RELEASES

MIDWEST INCOME TRUST

A notice has been issued giving interested persons until December 1 to request a hearing on an application filed by Midwest Income Trust, Midwest Group Tax Free Trust, and Financial Independence Trust and all future investment companies which are advised by Midwest Advisory Services, Inc. or Financial Independence Trust Advisers, Inc. (Funds). The application requests an order exempting them from Section 32(a)(1) of the Investment Company Act to permit the Funds to file financial statements signed or certified by an independent public accountant selected at a board of trustees meeting held within 90 days after the beginning of each fund's fiscal year. (the Partnership), Technology Funding Inc., and Technology Funding Ltd. determining that: (1) the independent general partners of the Partnership are not "interested persons" of the Partnership, the other general partners, or the principal underwriter of the Partnership solely by reason of their status as general partners of the Partnership and co-partners of the other general partners; and (2) no limited partner owning less than 5% of the units of limited partnership interest in the Partnership is an "affiliated person" of the Partnership or any of its partners solely by reason of being a limited partners. SYSTEM ENERGY RESOURCES, INC.; NEW ENGLAND ELECTRIC SYSTEM
