#### CIVIL PROCEEDINGS

CIVIL INJUNCTIVE ACTION FILED AGAINST DON S. PETERS, OTHERS

The Commission filed a civil injunctive action on December 28 in the U.S. District Court for the District of Kansas against Don S. Peters, Kenneth L. Mick, Jimmie Lee Pfeffer, Ernest C. Doyon, Jr., Bernard Lounsbury, and Bonaventure A. Kreutzer, Jr. alleging that they violated the antifraud provisions of the Securities Exchange Act of 1934 and that Peters, Mick, Pfeffer, and Lounsbury also violated the tender offer provisions of the Exchange Act.

The Commission alleges that Peters, an investment adviser with a Wichita, Kansas firm, misappropriated material non-public information concerning a tender offer by Broken Hill Proprietary Company for Energy Reserves Group, Inc. (ERG), from his partner, a consultant to ERG. The Commission alleges that Peters and Mick, a broker, devised a scheme to profit from such information through the trading of others in ERG stock. According to the Complaint, Mick or Peters induced Pfeffer, Lounsbury, Doyon, and Kreutzer to purchase a total of 170,000 shares of ERG stock in return for a share of any resulting profits which Mick then shared with Peters. The defendants sold their stock after the tender offer was announced.

The Commission is seeking injunctions, disgorgement of profits totalling \$333,000, and Insider Trading Sanctions Act penalties. (SEC v. Don S. Peters, et al., USDC DKS, Civil Action No. 88 Civ. 1720-K). (LR-11950)

#### **CRIMINAL PROCEEDINGS**

HENRY A. PAWLIK INDICTED

The U.S. Attorney for the Northern District of Illinois and the Chicago Regional Office announced that on December 8 Henry A. Pawlik of Homewood, Illinois was indicted for mail, wire, and tax fraud. The indictment alleges, among other things, that Pawlik misappropriated more than \$400,000 in customer funds from his brokerage firm, EBS Brokerage Services, Inc. The indictment further alleges that Pawlik converted the customer funds to his own use. If convicted, Pawlik faces a maximum jail term of 12 years and \$52,000 in fines. (U.S. v. Henry A.
