U.S. SECURITIES AND EXCHANGE COMMISSION

FREDERICK M. FRIEDMAN SENTENCED

The New York Regional Office announced that on January 30 Frederick M. Friedman of New York, New York, vice president of TDA Industries, Inc., was sentenced by the Honorable Inzer B. Wyatt, U.S. District Judge for the Southern District of New York, following his conviction on two counts of mail fraud and one count of wire fraud in the case captioned below. Friedman was sentenced to one month imprisonment on each of three counts, to run concurrently, and a fine of \$3,000. This sentence is to run consecutively to a three month sentence announced on January 10 in connection with other transactions involving TDA. Imposition of the sentences and fines was stayed pending appeal. (U.S. vs. Frederick M. Friedman and Alan E. Sandberg, 76 Cr. 1022, S.D.N.Y.). (LR-8994)
