ENFORCEMENT PROCEEDINGS

ADMINISTRATIVE PROCEEDINGS INSTITUTED AGAINST JOSEPH BROOKS

The Commission has instituted administrative proceedings, pursuant to Sections 15(b) and 19(h) of the Securities Exchange Act of 1934 (Exchange Act) against Joseph P. Brooks (Brooks) of Ft. Myers, Florida. The Order Instituting Proceedings alleges that on December 4, 1995, Brooks pled no contest to a one-count criminal information charging him with first degree grand theft (State of Florida vs. Joseph P. Brooks, Case No. 95-2536 CF, Circuit Court of Lee County, Florida).

The Order further alleges that on September 4, 1996, a default final judgment of permanent injunction was entered against Brooks, permanently enjoining him from future violations of Section 17(a) of the Securities Act of 1933, Section 10(b) of the Exchange Act and Rule 10b-5, thereunder (SEC v. Joseph Brooks, Case No. 96-235-Civ-FTM-23, M.D. Fla.). On June 27, 1996, the Commission filed a complaint against Brooks, alleging that between approximately October 1991 and June 1995, Brooks misappropriated approximately \$366,300 from eight mostly elderly investors. The complaint further alleged that Brooks utilized a scheme whereby he opened up bank accounts in his and his customers' names by forging their names on new account documents, forging requests for the release of cash management account funds, and arranging to have the released funds forwarded by check to the addresses he controlled. INVESTMENT COMPANY ACT RELEASES

THE OFFITBANK INVESTMENT FUND, INC., ET AL.

A notice has been issued giving interested persons until January 31 to request a hearing on an application filed by The OFFITBANK Investment Fund, Inc. (OFFITBANK Fund), The OFFITBANK Variable Insurance Fund, Inc. (OFFITBANK VIF), and OFFITBANK for an order

under Section 12(d)(1)(J) of the Investment Company Act exempting applicants from Section 12(d)(1) of the Act, and under Sections 6(c) and 17(b) of the Act exempting applicants from Section 17(a) of the Act. The requested order would permit OFFITBANK Total Return Fund, a new series of OFFITBANK Fund, and OFFITBANK VIF-Total Return Fund, a series of OFFITBANK VIF, to invest all or a portion of their assets in series of OFFITBANK Funds and OFFITBANK VIF in excess of the percentage limitations of Section 12(d)(1). SPECIAL PORTFOLIOS, INC.

A notice has been issued giving interested persons until February 10, 1997 to request a hearing on an application filed by Special Portfolios, Inc. for an order under Section 8(f) of the Investment Company Act declaring that applicant has ceased to be an investment company. (Rel. IC-22442 - January 6)

SELF-REGULATORY ORGANIZATIONS

PROPOSED RULE CHANGE

Pursuant to Rule 19b-4 under the Securities Exchange Act of 1934, the <u>American Stock Exchange</u> (SR-Amex-96-45) filed with the Commission on December 5, 1996 a proposed rule change to modify the closing time for equity options and narrow-based index options. Publication of the proposal is expected to be made in the <u>Federal Register</u> during the week of January 6. (Release No. 34-38123)

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission granted accelerated approval of a proposed rule change (SR-Philadep-96-22) filed under Section 19(b) of the Securities Exchange Act by the <u>Philadelphia Depository Trust Company</u>. The proposed rule change establishes family of accounts processing procedures. Publication of the proposal is expected in the <u>Federal Register</u> during the week of January 6. (Rel. 34-38120)

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change submitted under Rule 19b-4 by The Chicago Stock Exchange (SR-CHX-96-16) to amend Article XX, Rule 37 and Article XX, Rule 43 relating to the trading of Nasdaq National Market (Nasdaq/NM) securities (previously known as NASDAQ/NMS securities) on the Exchange. (Rel. No. 34-38119)

DELISTING

An order has been issued granting the application of the American Stock Exchange to strike from listing and registration A + Network, Inc., 11 7/8% Senior Subordinated Notes, due 2005. (Rel. 34-38129)
