#### **ENFORCEMENT PROCEEDINGS**

### JOSEPH GALLUZZI CHARGED IN MUNICIPAL SECURITIES KICKBACK SCHEME

The Commission filed a complaint today in federal court in Newark, New Jersey, alleging that Joseph P. Galluzzi (Galluzzi) violated the antifraud provisions of the Securities Exchange Act of 1934 (Exchange Act) arising from payments of more than \$250,000 in undisclosed kickbacks that Galluzzi received from First Fidelity Securities Group (FFSG) and A.G. Edwards & Sons, Inc. between April 1987 and December 1993 in connection with issuances of municipal securities by Essex County, New Jersey (Essex County), the Essex County Improvement Authority (ECIA) and the Township of Irvington, New Jersey (Irvington). During the period of the conduct alleged in the complaint, Joseph P. Galluzzi was either a financial consultant to the Freeholders of Essex County, a financial consultant to Essex County, or the Treasurer of Essex County; and was a financial consultant to the Municipal Council of Irvington.

The Commission seeks a final judgment permanently enjoining Galluzzi from future violations of Section 10(b) of the Exchange Act and Rule 10b-5. In addition, the Commission seeks disgorgement of the kickbacks he received and prejudgment interest.

FFSG previously settled an administrative proceeding arising out of the same kickback scheme, in which it, without admitting or denying the findings, consented to the issuance of an order finding that FFSG willfully violated Section 17(a) of the Securities Act of 1933, and Sections 10(b) and 15B(c)(1) of the Exchange Act and Rule 10b-5, and Rules G-8, G-17 and G-20 of the Municipal Securities Rulemaking Board, and requiring FFSG to pay disgorgement and prejudgment interest in the amount of \$1,793,309.43 and pay a \$500,000 penalty (See In the Matter of First Fidelity Securities Group, Exchange Act Release No. 36694 (Jan. 9, 1996), 61 SEC Docket 68 (Feb. 6, 1996). [SEC v. Joseph P. Galluzzi, Civil Action No. 97-76, D.N.J.] (LR-15211)

#### JUDGMENT OF PERMANENT INJUNCTION AGAINST JAMES FALLER II

On December 18, the Honorable Lenore C. Nesbitt, United States District Judge for the Southern District of Florida, entered an order of permanent injunction enjoining James S. Faller II (Faller) from violating Section 17(a) of the Securities Act of 1933 and Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder.

The Court further ordered Faller to pay disgorgement in the amount of \$9,028, plus prejudgment interest thereon, representing gains alleged to have been received by Faller following his purchase of 20,000 shares of Evro Corporation (Evro) common stock while in possession of material non-public information concerning Evro.

Faller consented to the relief without admitting or denying the allegations set forth in a complaint filed by the Commission on September 30, 1996. The complaint alleged that Faller and his codefendant, Rolan Colon (Colon), while acting as consultants for Evro, caused the corporation to issue a false press statement stating that Evro had obtained a \$30 million loan commitment from a European trust to finance the development and sale of Evro products, while knowing the purported loan commitment was fictitious. The press release caused an immediate and positive rise in the price of Evro common stock at which time Faller sold his shares of the corporation's stock. [SEC v. James S. # SELF-REGULATORY ORGANIZATIONS

# IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGES

A proposed rule change filed by the <u>National Association of Securities Dealers</u> to modify the NASD's minimum gross income assessment (SR-NASD-96-56) has become effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. Publication of the proposal is expected in the <u>Federal Register</u> during the week of January 13. (Rel. 34-38126)

A proposed rule change (SR-NASD-96-57) filed by the <u>National Association of Securities Dealers</u> to recoup from its members SEC transaction fees assessed against the NASD pursuant to recently enacted legislation, has become immediately effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. Publication of the notice is expected in the <u>Federal Register</u> during the week of January 13. (Rel. 34-38133)

### PROPOSED RULE CHANGES

The <u>American Stock Exchange</u> filed a proposed rule change (SR-AMEX-96-46) to amend Rule 170 to permit options specialist organizations and their approved persons to engage in market making activities on other options exchanges in the options in which they are registered on the AMEX. Publication of the proposal is expected in the <u>Federal Register</u> during the week of January 13. (Rel. 34-38128)

The <u>Boston Stock Exchange</u> filed a proposed rule change (SR-BSE-96-12) to amend Chapter II, Section 34A of its rules (Trading Halts Due to Extraordinary Market Volatility - Circuit Breakers), to adopt new thresholds for triggering its Circuit Breakers. Publication of the proposal is expected in the <u>Federal Registe</u>: during the week of January 13. (Rel. 34-38138)

# APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change and issued notice of filing and granted accelerated approval to Amendment No. 1 to the proposed rule change submitted by the <u>National Association of Securities Dealers</u> (SR-NASD-96-08) to permit the quotation of Direct Participation Programs (DPPs) on the OTC Bulletin Board Service and to require that all transactions in DPPs be reported through the Automated Confirmation Transaction Service. (Rel. 34-38132)

The Commission approved a proposed rule change (SR-Amex-96-34) filed by the <u>American Stock Exchange</u> which provides that the Amex will not object to the assertion of independent contractor status by a natural person who is a registered representative, securities lending representative or securities trader if such status will not preclude his or her characterization and treatment as an employee for purposes of the Constitution and Rules of the Amex. Publication of the approval order is expected in the <u>Federal Register</u> during the week of January 13. (Rel. 34-38140)
