RULES AND RELATED MATTERS

ADOPTION OF DISCLOSURES REGARDING ACCOUNTING POLICIES FOR AND MARKET RISKS INHERENT IN DERIVATIVES AND OTHER INSTRUMENTS

On January 28, the Commission adopted amendments to revise Rule 4-08 of Regulation S-X to provide for specific disclosures of registrants' accounting policies for derivative financial instruments and derivative commodity instruments, and to add Item 305 to Regulation S-K and Item 9A to Form 20-F to provide for disclosure of quantitative and qualitative information about market risks inherent in derivative financial instruments, other financial instruments, and derivative commodity instruments. ENFORCEMENT PROCEEDINGS

CIVIL AND CRIMINAL ACTIONS AGAINST CHARLES HUTTOE

The Commission announced that Charles O. Huttoe (Huttoe), formerly the Chairman and Chief Executive Officer of Systems of Excellence. Inc. (SOE) was sentenced to a prison term of 46 months followed by two years supervised release and a \$10,000 fine. Huttoe had pled guilty to a two count information charging him with securities fraud and money laundering for his role in the unregistered distribution of SOE stock to his nominees, the sale of that stock after the price was increased pursuant to a scheme to manipulate the market for that stock and the subsequent transfer of millions of dollars of the proceeds of those sales to others. On November 7, 1996, the Commission obtained a Temporary Restraining Order (TRO) against Huttoe and others based on a complaint alleging a massive securities The TRO among other things prohibited ongoing fraud at SOE. violations of the securities laws, froze Huttoe's assets and prohibited him from traveling outside the United States. The criminal case against Huttoe was the result of a coordinated investigative effort by the Commission, the U.S. Attorney's Office for the Eastern District of Virginia and the Internal Revenue Service - Criminal Investigation Division from Northern Virginia and Las Vegas, Nevada. CIVIL ACTION FILED AGAINST ROBERT WHITE; WHITE CONSENTS TO INJUNCTION

On January 30, the Commission announced the filing of an injunctive action against Robert C. White (White) in the United States District Court, Eastern District of California. A related criminal action was also filed against White by the U.S. Attorney's Office.

The Commission's complaint alleges that from 1988 through October 1996, White fraudulently raised about \$1.9 million from over 30 investors to invest in stocks, bonds and mutual funds through a securities dealer he was purportedly associated with, PDR Group, Inc. (PDR). White did not invest investors' money in securities. Rather, he misused investor funds to pay returns to investors, to pay his personal expenses and to fund his unrelated oil and gas business. In addition, PDR has never been registered with the Commission.

The complaint further alleges that White drafted and gave to investors fictitious account statements falsely showing profitable securities trading on investors' behalf. The account statements also falsely stated that investor accounts were insured by the Securities Investor Protection Corporation. Without admitting or denying the allegations in the complaint, White consented to be enjoined from future violations of the antifraud provisions of the federal securities laws.

INVESTMENT COMPANY ACT RELEASES

SBSF FUNDS, INC. D/B/A/ KEY MUTUAL FUNDS, ET AL.

A notice has been issued giving interested persons until February 24 to request a hearing on an application filed by SBSF Funds, Inc. d/b/a Key Mutual Funds, et al. for an order under Section 12(d)(1)(J) of the Investment Company Act exempting applicants from Sections 12(d)(1)(A) and (B) of the Act, and under Sections 6(c) and 17(b) of the Act exempting applicants from Section 17(a) of the Act. The order would permit applicants to implement a "fund of funds" arrangement. In addition to the fund of funds investing in other funds in the same group of investment companies, such fund of funds also may invest a portion of its assets in funds that are not part of the same group of investment companies in reliance on Section 12(d)(1)(F) of the Act.
