ENFORCEMENT PROCEEDINGS

COMMISSION AFFIRMS FINDING OF VIOLATIONS AND MODIFIES SANCTIONS AGAINST JAMES SNELGROVE AND DAVID DISNER

The Commission has affirmed a finding of violations against James Snelgrove, formerly the chief trader for the now-closed B.C. Financial Corp, and David Disner, the former president of B.C. Financial. The Commission also has modified, in part, the sanctions the administrative law judge imposed against Snelgrove and Disner.

The Commission found that, between June 1989 and November 1989, Disner and Snelgrove violated the antifraud provisions of the securities laws by charging customers undisclosed, fraudulent markups and markdowns in securities transactions, and by aiding and abetting B.C. Financial's charging undisclosed, unfair markups and markdowns.

The Commission affirmed the portion of the law judge's order that barred Snelgrove and Disner from participating in any offering of a penny stock and ordered Disner and Snelgrove permanently to cease and desist from committing or causing any violation or future violation of Section 17(a) of the Securities Act of 1933 and Sections 10(b) and 15(c) of the Securities Exchange Act of 1934, and Rules 10b-5 and 15c1-2 thereunder. The Commission, however, increased the sanctions ordered by the law judge to bar Disner and Snelgrove from association with any broker or dealer, with the right to reapply after three years. EMERGENCY CIVIL ACTION FILED AGAINST BROKER-DEALER FOR REFUSING TO PROVIDE RECORDS TO COMMISSION

The Commission announced that on February 4 it filed a civil lawsuit in the U.S. District Court for the Southern District of Florida against J.W. Korth & Co. (JWK), a registered broker-dealer which has been offering and selling to the public defaulted pre-World War II German Gold Bonds (German Bonds). JWK, headquartered in Farmington Hills, Michigan, is conducting its German Bond business from its branch office in Miami, Florida. James Wilder Korth (Korth), JWK's president, age 46 of Coconut Grove, Florida, is also named as a defendant in the lawsuit.

The SEC's complaint and supporting papers allege that JWK, under Korth's direction, has repeatedly refused to give the SEC true and complete copies of records containing the certificate numbers for these German Bonds in violation of Sections 17(a)(1) and 17(b) of the Securities Exchange Act of 1934 (Exchange Act) and Rule and 17a-4(j) thereunder. The SEC charges that Korth violated these provisions as an aider and abettor, pursuant to Section 20(f) of the Exchange Act. According to its complaint, the SEC has received preliminary information tending to indicate that the vast majority of the German Bonds currently in circulation may be invalid and unredeemable.

The suit seeks a temporary restraining order, preliminary and permanent injunctions, a civil penalty and certain ancillary relief. [SEC v. J.W. Korth & Co. and James Wilder Korth, Case No. 97-0280-Civ-Ungaro-Benages, USDC/SD FL] (LR-15244)
