ENFORCEMENT PROCEEDINGS

SETTLEMENT IN RULE 102(E) PROCEEDING AGAINST PHILIP GREIFELD, CPA

On February 20, the Commission announced that it settled administrative proceedings instituted pursuant to Rule 102(e) of the Commission's Rules of Practice against Philip Greifeld, CPA, finding that he engaged in improper professional conduct.

The Commission's Order finds that Greifeld engaged in improper professional conduct in connection with the 1991 audit of A.S. Goldmen & Co., Inc. (Goldmen) and the 1991 and 1992 audits of Middlegate Securities, Ltd. in several respects. First, his participation in the audits of both clients was not sufficient for him to assure that proper audit procedures required by generally accepted auditing standards (GAAS) were employed. Specifically, Greifeld failed to comply with several of the tenets of GAAS, including all of the standards of field work and the requirement that he exercise due care in the performance of the audit. Second, he failed to comply with Rule 17a-5, 17 C.F.R. § 240.17a-5, and GAAS when he did not perform reasonable procedures to ensure that another accountant working with him was independent during the 1991 audit of Goldmen. Third, he was not at the time he signed the audit reports registered as an accountant as required by Rule 17a-5(f).

Without admitting or denying the findings, Greifeld agreed to the entry of an Order pursuant to Rule 102(e) denying him the privilege of appearing or practicing before the Commission as an accountant, with the right to reapply after two years as a preparer or reviewer, or person responsible for the preparation or review, of financial statements, and after five years as an independent accountant, subject to the conditions set forth in the Order. PARTNERS INCOME FUND

A notice has been issued giving interested persons until March 17 to request a hearing on an application filed by Partners Income Fund for an order under Section 6(b) of the Investment Company Act. The requested order would amend a condition of a prior order to permit the employer of certain employees' securities companies to invest in those companies on terms no more favorable than those available to eliqible employees. PROPOSED RULE CHANGES
