COMMISSION ANNOUNCEMENTS

ADOPTION OF UPDATED EDGAR FILER MANUAL

The Commission is adopting an updated edition of the EDGAR Filer Manual and is providing for its incorporation by reference into the Code of Federal Regulations. (Rel. Nos. 33-7394; 34-38319; 35-26672; 39-2346; IC-22522)

ENFORCEMENT PROCEEDINGS

JONATHAN MENDE & ASSOCIATES, INC., JONATHAN MENDE, TODD HICKMAN, MITCHELL AGUIRRE, AND YEVGENY SHKILKO SANCTIONED

The Commission announced the acceptance of Offers of Settlement from Jonathan Mende & Associates, Inc. (Mende & Associates), Jonathan Aurielio Mende (Mende), Todd Levaughn Hickman (Hickman), Mitchell Aguirre (Aguirre), and Yevgeny G. Shkilko (Shkilko) (collectively, Settling Respondents). In their Offers of Settlement, Mende & Associates, Mende, Hickman, Aguirre, and Shkilko consented to the issuance of cease-and-desist orders against them; Mende, Hickman, Aguirre, and Shkilko consented to be barred from participating in the offering of any penny stock; Mende, Hickman, and Aguirre consented to be barred from association with any broker, dealer, investment company, investment adviser or municipal securities dealer; and Shkilko consented to be barred from association with any broker, dealer, investment company, investment adviser or municipal securities dealer, with a right to reapply for such association in two years. In addition, Mende & Associates, Mende, Hickman, Aguirre, and Shkilko were ordered to disgorge \$205,175, \$205,175, \$29,136, \$64,598.36, and \$2,000 in ill-gotten gains, respectively, plus prejudgement interest. Payment of disgorgement was waived and the Settling Respondents were not ordered to pay civil money penalties based on their demonstrated financial inability to pay.

The Commission's Order makes findings that, from about March through October 1993, Mende & Associates operated as an unregistered broker-dealer and violated the antifraud provisions of the Securities Act of 1933 and Securities Exchange Act of 1934 (Exchange Act), and the

penny stock rules of the Exchange Act. Mende & Associates was operated by Mende and Hickman. Mende and Hickman also engaged in fraudulent securities sales practices. For example, Mende and baseless predictions, made price misrepresentations, and failed to disclose material facts concerning the imminent listing of speculative securities on the American Stock Exchange or on Nasdag, the experience and expertise of Mende & Associates personnel, and the financial condition and history of issuers of, and the risks of investing in, speculative securities. The Order also makes findings that, from about May 1993 through February 1994, Aguirre, who was an unregistered salesman at M. Rimson & Co., Inc. (Rimson & Co.), engaged in fraudulent sales practices. For example, Aguirre made baseless price predictions, material misrepresentations, and failed to disclose material facts concerning the imminent listing of speculative securities on Nasdag, the risks of investing in speculative securities, and his receipt of compensation from a promoter of certain speculative securities. Aguirre also effected unauthorized trades in his customers' accounts and misappropriated customer funds. Finally, the Order makes findings that, from about June through November 1994, Shkilko, who was a registered representative at Rimson & Co., willfully aided and abetted and caused certain other respondents' violations of the antifraud and books and records provisions. For example, Shkilko authorized David Feyjin and Roger Dantoni II to misrepresent themselves as "Gene Shkilko" while soliciting customers to engage in securities transactions. Shkilko received customer orders transmitted by Feyjin and Dantoni from outside the offices of Rimson & Co., opened the customer accounts at Rimson & Co., and had the orders executed at Rimson & Co. under Shkilko's registered representative number. The Settling Respondents neither admitted nor denied the findings contained in the Order. (Rel. Nos. 33-7395; 34 - 38320)

JUDGMENT OF PERMANENT INJUNCTION AGAINST ROLAN COLON

On January 15, the Honorable Lenore C. Nesbitt, United States District Judge for the Southern District of Florida, entered a final judgment of permanent injunction and other relief enjoining Rolan Colon (Colon) from violating Section 17(a) of the Securities Act of 1933 and Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder.

The Court further ordered Colon to pay disgorgement in the amount of \$17,559, plus prejudgment interest thereon, representing gains alleged to have been received by Colon following his purchase of 20,000 shares of Evro Corporation (Evro) common stock while in possession of material non-public information concerning Evro.

Colon consented to the relief without admitting or denying the allegations set forth in the complaint, filed by the Commission on September 30, 1996. The complaint alleged that Colon and his codefendant, James S. Faller (Faller), while acting as consultants for Evro, caused the corporation to issue a false press statement stating that Evro had obtained a \$30 million loan commitment from a

European trust to finance the development and sale of Evro products, while knowing the purported loan commitment was fictitious. The press release caused an immediate and positive rise in the price of Evro common stock at which time Colon sold his shares of the corporation's stock. [SEC v. James S. The Stock Clearing Corporation of Philadelphia filed a proposed rule change (SR-SCCP-96-14) relating to the collection of Section 31 fees for the National Association of Securities Dealers.
