## RULES AND RELATED MATTERS

COMMISSION ISSUES FOR COMMENT PROPOSED AMENDMENTS TO FORM N-1A AND PROPOSED RULES 498 AND 35d-1

On February 27, the Commission issued for public comment: (i) proposed amendments to Form N-1A under the Investment Company Act of 1940 and the Securities Act of 1933, which would revise the disclosure requirements for mutual fund prospectuses to focus prospectus disclosure on essential information about a particular fund that would assist an investor in deciding whether to invest in that fund; (ii) proposed Rule 498 under the Securities Act and the Investment Company Act, which would permit investors to buy mutual fund shares based on a summary document, or profile, that would provide key information about a mutual fund with the fund's prospectus delivered with the purchase confirmation; and (iii) proposed Rule 35d-1 under the Investment Company Act, which would require mutual funds and other registered investment companies with names suggesting that the company focuses on a particular type of investment (e.g., a fund that calls itself the ABC Stock Fund, the XYZ Bond Fund, or the QRS U.S. Government Fund) to invest at least 80% of its assets in the type of investment suggested by its name. ## ENFORCEMENT PROCEEDINGS

BROKER CONSENTS TO SECURITIES INDUSTRY BAR

The Commission announced the institution of public administrative proceedings pursuant to Sections 15(b) and 19(h) of the Securities Exchange Act of 1934 (Exchange Act) against David Schaen (Schaen). Simultaneously with the institution of the proceedings, the Commission accepted Schaen's offer of settlement, in which he consented, without admitting or denying certain of the Commission's findings, to the issuance of an Order, effective immediately, barring Schaen from association with any broker, dealer, investment adviser, investment company or municipal securities dealer.

The Commission's Order finds that from in or about June and July 1990, Schaen was the sole principal of a registered broker-dealer in his name located in Chicago, which engaged in market making activities with the Chicago Board of Options Exchange. The Order also finds that on January 28, 1997, Schaen was permanently enjoined, by consent, by the United States District Court for the Southern District of New York from violations of Section 10(b) and 14(e) of the Exchange Act and Rules 10b-5 and 14e-3 thereunder in SEC v. Thrasher. et al., 92 Civ. 6987 (JEK) (S.D.N.Y.). Thrasher, the Commission alleged, among other things, that Hugh Thrasher (Thrasher), an officer at Motel 6, L.P. (Motel 6), communicated material, nonpublic information concerning negotiations for the acquisition of Motel 6 to his close personal friend, Carl Harris (Harris), who thereafter tipped numerous people, including his stepbrother, Schaen, who purchased Motel 6 securities. FINAL JUDGMENTS OF PERMANENT INJUNCTIONS AND OTHER RELIEF ENTERED AGAINST ROSEANN MARTUCCI, JAY HARTMAN, AND GARR MANAGEMENT SERVICES, INC.

On February 20, Final Judgments of Permanent Injunction and Other Relief (Final Judgments) were entered in the U.S. District Court for the Southern District of New York against defendants Roseann Martucci (Martucci), Jay R. Hartman (Hartman) and Garr Management Services, Inc. (Garr Management Services), a company owned in part by Martucci and Hartman. Each consented to the entry of the Final Judgments without admitting or denying the allegations of the complaint. The Final Judgments enjoin Martucci, Hartman and Garr Management Services from violations of Sections 10(b) and 14(e) of the Securities Exchange Act of 1934 and Rules 10b-5 and 14e-3 promulgated thereunder. The Final Judgments also order Martucci, Hartman and Garr to pay disgorgement, prejudgment interest and civil monetary penalties pursuant to the Insider Trading and Securities Fraud Enforcement Act totaling \$146,121.22.

The Commission's complaint filed on April 25, 1996 alleges that, in 1992, Sheri Kleinbaum, by virtue of her employment with a law firm, learned material nonpublic information relating to the identity of two acquisition targets of clients of the firm. Shortly after learning this information, Sheri Kleinbaum communicated it to her Sheri Kleinbaum's step-mother then father and step-mother. communicated material nonpublic information about the companies to Roseann Martucci, who in turn tipped business associates, Jay Hartman and the late Raymond G. Jerro, as well as a close personal friend. Roseann Martucci, Jay Hartman and Garr Management Services subsequently purchased the common stock of the targets prior to the public announcements that each was to be acquired. [SEC v. ## INVESTMENT COMPANY ACT RELEASES

THE MUTUAL LIFE INSURANCE COMPANY, ET AL.

An order has been issued pursuant to Sections 26(b) and 17(b) of the Investment Company Act on an application filed by The Mutual Life Insurance Company of New York, MONY Life Insurance Company of America and their respective separate accounts (Accounts), MONY Variable Account A and MONY America Variable Account A. The order approves the substitution of shares of the U.S. Government Series of OCC Accumulation Trust (Trust) held by the Accounts for shares of the Bond Series of the Trust. The order also grants exemptions from Section 17(a) to permit Applicants to carry out the above-referenced substitution in part by redeeming shares of the Bond Series in kind, and using the redemption proceeds to purchase shares of the U.S. Government Series. ## HOLDING COMPANY ACT RELEASES

# ENTERGY CORPORATION

A memorandum opinion and order has been issued authorizing Entergy Corporation, a registered holding company, to obtain bank loans in an amount up to \$500 million from time to time through December 31, 2002. Entergy will use the proceeds for acquisitions of its outstanding common stock and nonutility investments. The order also denies a request for a hearing. (Rel. 35-26674)

The Commission granted accelerated approval of a proposed rule change submitted by the <u>Chicago Stock Exchange</u> (SR-CHX-97-02) relating to Enhanced SuperMAX. Publication of the notice is expected in the <u>Federal Register</u> during the week of March 3. (Rel. 34-38338)

# PROPOSED RULE CHANGE

The Depository Trust Company filed a proposed rule change (SR-DTC-96-22) that will amend DTC's charge back and return of funds procedures to reduce from ten business days to one business day the period within which a paying agent can request that DTC return funds to the paying agent. Publication of the proposal is expected in the Federal Register during the week of March 3. (Rel. 34-38340)
