COMMISSION ANNOUNCEMENTS

CHAIRMAN LEVITT AND COMMISSIONERS WALLMAN, HUNT, AND JOHNSON TO TESTIFY

On Thursday, March 6, Chairman Levitt and Commissioners Wallman, Hunt, and Johnson will testify before the House Subcommittee on Finance and Hazardous Materials concerning the Commission's authorization for appropriations for fiscal years 1998-1999. The hearing will begin at 10:00 a.m. in Room 2322 of the Rayburn House Office Building.

ENFORCEMENT PROCEEDINGS

FINAL JUDGMENTS OF PERMANENT INJUNCTION ENTERED AGAINST JOY BOUWKAMP, JOE HALLOCK AND THOMAS GRAHOVAC

The Commission announced that on January 15 the United States District Court for the Central District of California entered a Final Judgment Of Permanent Injunction against defendant Joy L. Bouwkamp. Final Judgments of Permanent Injunction were also entered against Joe L. Hallock and Thomas M. Grahovac on February 5, 1997 and February 6, 1997, respectively.

The Commission's complaint, filed on September 6, 1995, named three other defendants and alleged that the principals of B.H. Rothchild & Gray (Canada) Lt'ee (B.H. Rothchild), raised approximately \$24 million from about 480 investors, during 1990-1992, in connection with a purported seafood financing program, which was to involve B.H. Rothchild's subsidiary Ocean Best Seafood & Trading, Inc. However, the program was non-existent. Investor funds were used to pay other investors and for unauthorized business and personal expenses. Bouwkamp, Hallock and Grahovac made misrepresentations and omissions of material fact in connection with the offer and sale of the investments. [SEC v. Joy L. PERMANENT INJUNCTION ORDERED AGAINST CHARLES HOWARD

On February 20, the Honorable Sharon Lovelace Blackburn, United States District Judge for the Northern District of Alabama, entered a final judgment of permanent injunction against defendant Charles L. Howard (Howard), enjoining him from violating Section 17(a) of the Securities Act of 1933 and Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder. Upon sworn representations of a financial inability to pay a fine, no civil penalties were imposed.

Howard consented to the relief without admitting or denying the allegations set forth in a complaint filed by the Commission on September 29, 1995. The complaint alleged that Howard, along with codefendants, violated the antifraud provisions of his securities laws in the offer and sale of municipal bonds, the proceeds of which were to be used for downtown redevelopment projects in White Hall, Alabama. Howard and codefendant Louis Bethune persuaded city officials to allow them to sell the bonds at face values disproportionate to the costs of the projects being funded by the bonds. The complaint also alleged that Howard and his codefendants misrepresented to investors that the bonds were backed by "Prime Bank Securities." In fact, none of the bonds offered for sale by Howard were ever guaranteed or secured by any financial instrument which could be described as a prime bank security. [SEC v. Louis Bethune, Charles L. INVESTMENT COMPANY ACT RELEASES

FIRST AMERICAN INVESTMENT FUNDS, INC., ET AL.

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change (SIPC-96-1) filed under Section 3(e)(2) of the Securities Investor Protection Act of 1970 (SIPA) by the Securities Investor Protection Corporation relating to the closeout and completion of contracts for the purchase or sale of securities made by debtors in liquidation under SIPA. Publication of the approval order is expected in the Federal Register during the week of March 10. (Rel. SIPA-163)
