COMMISSION ANNOUNCEMENTS

RESUMPTION OF SERVICE ON PRIMARY EDGAR COMPUTER SYSTEM

As of 8:00 a.m. this morning, service on the primary EDGAR computer system was restored. All service on the primary system had been interrupted by a power failure on March 21, 1997. During the outage, filings were received, analyzed and disseminated by a back-up system for the remainder of that day. Staff successfully brought the primary system back to full operational status over the weekend.

ENFORCEMENT PROCEEDINGS

PERMANENT INJUNCTION AND OTHER EQUITABLE RELIEF ORDERED AGAINST PAUL SHIFFMAN

The Commission today announced the entry of a final judgment against Paul Jay Shiffman on March 5. The Commission's complaint, which was filed on August 7, 1996, alleged that between approximately July 1993 and August 1994, Shiffman participated in the fraudulent offer and sale of unregistered securities in the Golden Triangle Wireless Television Partnership, a California general partnership. The complaint also alleged that the fraudulent offering raised \$8 million and that the unregistered securities were sold to 550 investors in more than 35 states.

Without admitting or denying the Commission's allegations, Shiffman consented to the entry of the final judgment, which permanently enjoins him from violating Sections 5(a), 5(c) and 17(a) of the Securities Act of 1933 and Section 10(b) of the Securities Exchange

Act of 1934 and Rule 10b-5 thereunder. The final judgment orders Shiffman to pay the sum of \$161,000, representing disgorgement of his gains from the conduct alleged in the complaint, but waives payment of the disgorgement based on Shiffman's demonstrated inability to pay. All other defendants in this action previously consented to the entry of final judgments of permanent injunction. For further information, see LR-15006, August 7, 1996. [SEC v.
