ENFORCEMENT PROCEEDINGS

FINDINGS MADE AND REMEDIAL SANCTIONS IMPOSED IN ADMINISTRATIVE PROCEEDINGS AGAINST DAVID MCCLURE

The Commission has determined to accept an offer of settlement submitted by David McClure (McClure) in resolution of the administrative proceedings instituted against him on September 30, 1996. Under the terms of the settlement, McClure has consented, without admitting or denying the findings, to a three month suspension from association with any broker, dealer, investment adviser, investment company or municipal securities dealer; an additional three month bar from acting in a supervisory capacity with any broker, dealer, investment adviser, investment company or municipal securities dealer; and a civil penalty of \$5,000.

The Commission's Order finds that, from May 1993 through January 1995, C'est Lestial Waters, Inc. (CWI) raised over \$7 million from more than 100 investors through the offering and sale of unregistered collateral trust bonds (CWI bonds), as well as the securities of certain entities related to CWI. In connection with that offering, CWI, certain of its principals and agents, as well as certain other entities and individual sales representatives, violated, variously, the securities registration, antifraud and broker-dealer registration provisions of the federal securities laws. Specifically, these entities and individuals made misrepresentations of material fact and failed to disclose material information concerning the security underlying the CWI bonds and their relative safety, their status as exempt from registration with the Commission, and the use of offering proceeds.

The Commission's Order finds that Michael D. Gibson, a registered representative formerly associated with O.N. Equities Sales Company (ONESCO), fraudulently offered and sold unregistered securities of CWI, and that McClure, a registered principal and vice president of Onseco, failed to reasonably supervise Gibson during part of the period Gibson was selling CWI securities. Specifically, the Order finds that, during his association with ONESCO, Gibson sold over \$2.7 million in CWI bonds misrepresenting, among other things, that each bond was fully secured with a first lien interest in certain CWI assets.

The Order finds that McClure failed to detect, investigate and adequately respond to facts and circumstances of which he had notice regarding Gibson's activities, in that, in delegating the task of reviewing Interview Forms and Outside Business Activity Reports to a clerical compliance assistant, McClure failed to provide any instructions as to the review of the Outside Business Activity Reports; and upon notice that Gibson was considering involvement, and/or was involved, with viatical settlements and the sale of bonds, McClure failed to promptly initiate an investigation into this information. FINDINGS MADE AND REMEDIAL SANCTIONS IMPOSED IN ADMINISTRATIVE PROCEEDINGS AGAINST GREGORY MOORE

The Commission has determined to accept an offer of settlement submitted by Gregory Moore (Moore) in resolution of the administrative proceedings instituted against him on September 30, 1996. Under the terms of the settlement Moore has consented, without admitting or denying the findings, to a nine month suspension from association with any broker, dealer, investment adviser, investment company or municipal securities dealer; disgorgement of \$11,000 plus prejudgment interest of \$1,000; and a cease-and desist order.

The Commission's Order finds that, from May 1993 through January 1995, C'est Lestial Waters, Inc. (CWI) raised over \$7 million from more than 100 investors through the offering and sale of unregistered collateral trust bonds (CWI bonds), as well as the securities of certain entities related to CWI. In connection with that offering, CWI, certain of its principals and agents, as well as certain other entities and individual sales representatives, violated, variously, the securities registration, antifraud and broker-dealer registration provisions of the federal securities laws. Specifically, these entities and individuals made misrepresentations of material fact and failed to disclose material information concerning the security underlying the CWI bonds and their relative safety, their status as exempt from registration with the Commission, and the use of offering proceeds.

The Commission's Order further finds that, from October 1994 through January 1995, Moore, a registered representative and an attorney licensed to practice law in Pennsylvania, offered and sold more than \$196,000 in the CWI bonds and received approximately \$11,000 in commissions therefrom. In connection with his sales of the CWI bonds, Moore made untrue statements of material facts to investors, including that the CWI bonds were fully secured through certain assets of CWI; the proceeds of the CWI bonds were to assist CWI in corporate expansion; and the financial stability of CWI was irrelevant because the CWI bonds were fully secured. The Order finds that, based on the conduct described above, Moore willfully violated Sections 5(a), 5(c) and 17(a) of the Securities Act of 1933, and Section 10(b) of the Securities Exchange Act of 1934, and Rule 10b-5 thereunder. TEMPORARY RESTRAINING ORDER GRANTED IN SEC V. STEPHEN MURPHY

On April 26, the Honorable James M. Ideman, United States District Judge for the Central District of California, entered a Temporary Restraining Order freezing the assets of Stephen J. Murphy a.k.a. Jack Davis (Murphy), a recidivist securities law violator. The Order also requires Murphy to provide an accounting and prohibits him from destroying documents.

The complaint alleges that Murphy violated Section 17(a) of the Securities Act of 1933, Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder by fraudulently offering and selling limited partnership interests in an enterprise that was to acquire, own and operate automated teller machines. Murphy misrepresented his identity by using the alias "Jack Davis." He also failed to disclose the entry of, and the terms of, a 1994 judgment entered against him in an earlier Commission action (SEC v. American Capital Investments, et al., Civil Case No. CV-93-5280 CBM, JRx, C.D. Cal.; LR-14185). Murphy also failed to disclose that in 1994 the Commission had revoked his registration as an investment adviser and barred him from association with any broker, dealer, municipal securities dealer, investment company or investment adviser. INVESTMENT COMPANY ACT RELEASES

THE DIAZ-VERSON FUNDS, INC.

A notice has been issued giving interested persons until May 16 to request a hearing on an application filed by The Diaz-Verson Funds, Inc. for an order under Section 8(f) of the Investment Company Act declaring that applicant has ceased to be an investment company. (Rel. IC-22627 - April 21)

THE ADVISORS' INNER CIRCLE FUND

An order has been issued on an application filed by The Advisors' Inner Circle Fund, on behalf of each series thereof, including any series created after the date of the application (together, the Portfolios), under Sections 6(c) and 17(b) of the Investment Company Act for an exemption from Section 17(a) of the Act. The order permits redemptions in-kind of shares of the Portfolios by shareholders who are "affiliated persons" of the Portfolios within the meaning of Section 2(a)(3)(A) of the Act. (Rel. STRONG INSURED MUNICIPAL BOND FUND, INC.

An order has been issued under Section 8(f) of the Investment Company Act declaring that Strong Insured Municipal Bond Fund, Inc. has ceased to be an investment company. (Rel. IC-22629 - April 22)

SELF-REGULATORY ORGANIZATIONS

PROPOSED RULE CHANGES

The <u>Pacific Exchange</u> filed a proposed rule change (SR-PCX-97-10) relating to Amendments to its Rule 2.16 (Margin Requirements). Publication of the proposal is expected in the <u>Federal Register</u> during the week of April 21. (Rel. 34-38528)

The <u>National Association of Securities Dealers</u> filed a proposed rule change (SR-NASD-97-27) to modify The Nasdaq Stock Market's automated quotation system to permit Nasdaq-listed securities whose bid is \$10 or higher to be quoted in increments as small as one sixteenth of a dollar. Publication of the proposal is expected in the <u>Federal Register</u> during the week of April 28. (Rel. 34-38531)

The <u>National Association of Securities Dealers</u> filed a proposed rule change (SR-NASD-97-21) to establish a new registration category, Equity Trader (Series 55), and a qualification examination. Publication of the proposal is expected in the <u>Federal Register</u> during the week of April 28. (Rel. 34-38534)

The <u>Chicago Board Options Exchange</u> (SR-CBOE-96-68) filed a proposed rule change to add an interpretation to its RAES rule for equity options specifying the trading crowd's firm quote obligation for RAES orders re-routed through the Exchange's Order Routing System (ORS) and clarifying when an order reaches the trading station for purposes of the firm quote rule. Publication of the proposal is expected in the <u>Federal Register</u> during the week of April 28. (Rel. 34-38535)

The MBS Clearing Corporation filed a proposed rule change (SR-MBSCC-97-02) to amend MBSCC's method of determining the value of securities deposited as collateral in the participants fund to satisfy the MBSCC margin requirement. Publication of the proposal is expected in the <u>Federal Register</u> during the week of April 28. (Rel. 34-38536)
