ENFORCEMENT PROCEEDINGS

IN THE MATTER OF GARY DIVALL AND PAUL MAGNUSON

The Commission instituted public administrative proceedings pursuant to Sections 15(b) and 19(h) of the Securities Exchange Act of 1934 (Exchange Act), against Gary J. DiVall and Paul E. Magnuson. Simultaneously, DiVall and Magnuson submitted offers of settlement, which the Commission accepted. Accordingly, the Commission entered an Order instituting administrative proceedings, making findings and imposing remedial sanctions. The Order finds that DiVall and Magnuson each violated the antifraud provisions of the Securities Act of 1933 and the books and records, reporting and antifraud provisions of the Exchange Act, and bars each of them from association with any broker, dealer, municipal securities dealer, investment adviser or investment company.

Specifically, the Order finds that DiVall and Magnuson were general partners of three public partnerships, DiVall Insured Income Fund Limited Partnership, DiVall Insured Income Properties 2 Limited Partnership and DiVall Income Properties 3 Limited Partnership, (collectively, DiVall Funds). The Order further finds that, between 1988 and 1992, DiVall and Magnuson made misrepresentations and omissions of material fact to investors and to the DiVall Funds' auditors concerning their personal use of over \$2.6 million that they had misappropriated from the DiVall Funds. The Order also finds that DiVall and Magnuson failed to keep adequate books and records reflecting their use of those investor funds for personal purposes, and, as controlling persons of the DiVall Funds, caused the filing of false and misleading periodic reports with the Commission. Finally, the Order finds that DiVall and Magnuson were, by consent, permanently enjoined by the Commission from violating the above described provisions of the federal securities laws. IN THE MATTER OF DOUGLAS DAMON, ROBERT DAVIS AND KENNETH KOLOVITZ

The Commission instituted public administrative proceedings pursuant to Sections 15(b) and 19(h) of the Securities Exchange Act of 1934 (Exchange Act), against Douglas R. Damon, Robert M. Davis and Kenneth R. Kolovitz. Simultaneously, Damon, Davis and Kolovitz submitted offers of settlement, which the Commission accepted. Accordingly, the Commission entered an Order instituting proceedings, making findings and imposing remedial sanctions. The Order finds that Damon, Davis and Kolovitz each violated the antifraud provisions of the Securities Act of 1933 and the securities registration and broker-dealer registration and antifraud provisions of the Exchange Act, and bars each of them from association with any broker, dealer, municipal securities dealer, investment adviser or investment company.

Specifically, the Order finds that, from approximately 1989 through October 1990, Damon operated Union Credit of Illinois Corporation (UCC), which purportedly purchased and leased machines for use by small retail businesses, for the sole purpose of issuing and offering securities. The Order further finds that, during that time, Damon, Davis and Kolovitz offered and sold unregistered UCC securities by making misrepresentations and omissions of material fact to investors concerning the use of their funds, the source of repayment to them, the risks associated with UCC securities and the returns they might realize. Finally, the Order finds that Damon, Davis and Kolovitz were, by consent, permanently enjoined by the Commission from violating the above described provisions of the federal securities laws. INVESTMENT COMPANY ACT RELEASES

SMITH BARNEY, INC., ET AL.

An order has been issued on an application filed by Smith Barney, Inc., et al. under Section 6(c) of the Investment Company Act for exemptions from Sections 2(a)(32), 2(a)(35), 22(d), and 26(a)(2) of the Act and Rule 22c-1 thereunder. The order also grants relief under Section 11(a) to modify a prior order granting an exemption from Section 11(c) permitting certain exchange offers of trust units. (Rel. IC-22655 - May 6)

GPU NUCLEAR, INC., ET AL.

An order has been issued authorizing a proposal by GPU Nuclear, Inc., both a service company and a public utility subsidiary company of GPU, Inc. (GPU), a registered holding company, to perform a range of non-nuclear technical, training, management and consulting services for Jersey Central Power & Light Company, Metropolitan Edison Company, and Pennsylvania Electric Company, all publicutility subsidiary companies of GPU; GPU International, Inc., a nonutility subsidiary company of GPU; GPU Service, Inc., a service company subsidiary of GPU; and GPU Generation, Inc., both a service company and a public utility subsidiary company of GPU.
