INVESTMENT COMPANY ACT RELEASES

THE KENT FUNDS

A notice has been issued giving interested persons until June 9 to request a hearing on an application filed by The Kent Funds for an order under Section 6(c) of the Investment Company Act. The order would exempt applicant from Sections 13(a)(2), 18(f)(1), 22(f), and 22(g) of the Act and Rule 2a-7 thereunder; under Sections 6(c) and 17(b) of the Act the order would grant an exemption from Section 17(a)(1) of the Act; and under Section 17(d) and Rule 17d-1 the order would permit applicant to enter into deferred fee arrangements with its trustees. PROPOSED RULE CHANGES

The Options Clearing Corporation filed a proposed rule change (SR-OCC-97-01) that will permit OCC participants to deposit shares (fund shares) issued by open-end management investment companies as a form of margin. The proposed rule change also will permit participants to deposit fund shares along with certain publicly traded trust units as escrow deposits.
