INVESTMENT COMPANY ACT RELEASES

EATON VANCE MANAGEMENT, ET AL.

An order has been issued on an application filed by Eaton Vance Management, et al. under Sections 6(c) and 23(c) of the Investment Company Act exempting applicants from certain provisions of Rule 23c-3 under the Act. The order permits certain closed-end investment companies to make rotating, monthly tender offers and impose early withdrawal charges. (Rel. IC-22709 - June 16)

CREDIT UNION GOVERNMENT SECURITIES FUND, INC.

An order has been issued under Section 8(f) of the Investment Company Act declaring that Credit Union Government Securities Fund, Inc. has ceased to be an investment company. (Rel. IC-22710 - June 17)

THE LATIN AMERICAN DISCOVERY FUND, INC., ET AL.

An order has been issued on an application filed by The Latin American Discovery Fund, Inc., et al., under Sections 6(c) and 17(b) of the Investment Company Act granting an exemption from Section 17(a) of the Act and under Rule 17d-1 thereunder permitting certain joint transactions. The order permits the applicant investment

companies (Funds) to lend their portfolio securities to affiliated broker-dealers, to compensate an affiliated lending agent with a fee based upon a share of the proceeds derived by the Funds from their securities lending activities, and to deposit cash collateral derived from the Funds' securities lending activities in one or more joint trading accounts or subaccounts. THE STRANGER FUND, L.P.

A notice has been issued giving interested persons until July 11 to request a hearing on an application filed by The Stranger Fund, L.P. for an order under Section 8(f) of the Investment Company Act declaring that applicant has ceased to be an investment company. (Rel. IC-22712 - June 17)

J.P. MORGAN INDEX FUNDING COMPANY I, ET AL.

A notice has been issued giving interested persons until July 14 to request a hearing on an application filed by J.P. Morgan Index Funding Company I, et al. for an order under Section 6(c) of the Investment Company Act granting an exemption from all provisions of the Act. The order would permit applicants, each a finance subsidiary of J.P. Morgan & Co. Inc., to sell their preferred beneficial interests and use the proceeds to finance the business activities of their parent company and their parent company's subsidiaries. (Rel. IC-22713 - June 17)

ARTHUR ANDERSEN FINANCIAL ADVISERS

A notice has been issued giving interested persons until July 7 to request a hearing on an application filed by Arthur Andersen Financial Advisers for an order under Section 203A(c) of the Investment Advisers Act. The order would permit Arthur Andersen Financial Advisers to continue to be registered with the SEC as an investment adviser after July 8, 1997, even though it does not have \$25 million of assets under management and might not otherwise meet the criteria set forth in Section 203A(a) of the Advisers Act for registration with the SEC as an investment adviser. ERNST & YOUNG INVESTMENT ADVISERS LLP.

A notice has been issued giving interested persons until July 7 to request a hearing on an application filed by Ernst & Young Investment Advisers LLP for an order under Section 203A(c) of the Investment Advisers Act. The order would permit Ernst & Young Investment Advisers LLP to continue to be registered with the SEC as an investment adviser after July 8, 1997, even though it does not have \$25 million of assets under management and might not otherwise
