ENFORCEMENT PROCEEDINGS

PROCEEDINGS INSTITUTED AGAINST STEVEN WERTMAN, ROBERT ORKIN, EDWARD DONNER, III AND EARL DAVID

The Commission instituted public administrative proceedings against four respondents alleged to have participated in a scheme in which Robert Orkin, then principal officer of a brokerage firm, R.B. Webster Investments, Inc., caused the firm to sell common stock of Teletek, Inc. in return for secret payments which were not disclosed to its customers. The Division of Enforcement alleges that Steven Wertman, a Staten Island stock promoter, arranged for secret payments to be made to Orkin in 1992 and that Teletek issued stock to an entity controlled by Orkin in 1993. The Division further alleges that Wertman and Orkin manipulated the market in Teletek stock in or about the Spring of 1992. The respondents are alleged to have willfully violated the antifraud provisions under the Securities Act of 1933 and the Securities Exchange Act of 1934. The proceedings are to determine whether the staff allegations are true and, in connection therewith to afford respondents an opportunity to establish any defenses and to determine what, if any, remedial action is appropriate.
