### ENFORCEMENT PROCEEDINGS

# COMPLAINT FILED AGAINST CLYDE LAMONDA AND CD ALTERNATIVES, INC.

The Commission announced that on July 9 it filed a complaint in the United States District Court for the Middle District of Florida charging Clyde Keith LaMonda (LaMonda) and CD Alternatives, Inc. (CD Alternatives) with having violated the antifraud and registration provisions of the federal securities laws. The complaint alleges that from approximately March 1994 to March 1995, LaMonda and CD Alternatives (through its predecessor corporation, The C.D. Exchange Limited, Inc.) held seminars at which they promoted corporate notes and solicited insurance agents to sell those notes. LaMonda and CD Alternatives subsequently received a commission from the notes'

issuers for each investment sold by an agent they enlisted. The complaint further alleges that during the seminars, LaMonda and CD Alternatives misrepresented that the notes were safe investments. The complaint also alleges that LaMonda and CD Alternatives acted as broker-dealers while not registered with the Commission.

The Commission's complaint asks that LaMonda and CD Alternatives be enjoined from further violations of the federal securities laws, that they be ordered to disgorge their ill-gotten gains, and that they pay a civil monetary penalty. ### SELF-REGULATORY ORGANIZATIONS

### IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

A proposed rule change filed the <u>Pacific Exchange</u> (SR-PCX-97-26) to adjust the member surcharge assessed for arbitration claims from a flat rate to a graduated rate based on the amount in dispute has become effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. Publication of the proposal is expected in the <u>Federal Register</u> during the week of July 14. (Rel. 34-38830)

# MODIFICATION OF EFFECTIVENESS OF PROPOSED RULE CHANGE

The Commission permanently approved a proposed rule change filed by the National Association of Securities Dealers (SR-NASD-97-01) to prohibit a SelectNet order from being cancelled until a minimum period of ten seconds has elapsed. The Commission is subsequently changing the effective date, with respect to the rule's application to SelectNet broadcast orders, from July 7, 1997 until a date no later than October 6, 1997. The NASD will provide notice to its membership of the definitive effective date. This additional time will permit market participants to make necessary system modifications. Publication of the change of effective date is

expected in the <u>Federal Register</u> the week of July 14. (Rel. 34-38823)
