## COMMISSION ANNOUNCEMENTS

#### CHAIRMAN LEVITT TO TESTIFY

Chairman Levitt will testify before the Senate Subcommittee on Securities on Thursday, July 24, 1997, at 10:00 a.m. in Room 538 of the Dirksen Senate Office Building. The subject matter concerns the impact of the Private Securities Litigation Reform Act of 1995.

#### ENFORCEMENT PROCEEDINGS

### SAMUEL FORSON BARRED

The Commission has barred Samuel O. Forson of Brooklyn from association with any broker or dealer. Forson was vice president of both Oxford Capital Securities, Inc., formerly a registered broker-dealer, and Oxford Consolidated Corporation, Oxford Capital's parent corporation (collectively, Oxford).

In 1992, Forson was permanently enjoined, with his consent, from further violations of registration and antifraud provisions of the securities acts. As outlined in the injunctive complaint, over a period of more than two years Forson unlawfully sold more than \$200,000 worth of unregistered Oxford debt securities. In addition, he made fraudulent representations to customers in connection with those sales. Forson falsely represented, among other things, that Oxford Capital had over \$30 million under asset management, and that payment of principal and interest on the securities being sold was guaranteed.
