## ENFORCEMENT PROCEEDINGS

MARC GEMAN SANCTIONED FOR VIOLATING ANTIFRAUD AND RECORD-KEEPING PROVISIONS OF THE FEDERAL SECURITIES LAWS

Administrative Law Judge G. Marvin Bober has issued an initial decision sanctioning Marc N. Geman, a securities lawyer and former chief executive officer and stockholder of Portfolio Management Consultants, Inc. (PMC), for aiding and abetting violations of antifraud and record-keeping provisions of the federal securities laws.

Judge Bober barred Mr. Geman from being associated with any broker or dealer, investment adviser, national securities exchange, or registered securities association. Mr. Geman was ordered to cease and desist from committing or causing violations or future violations of the antifraud and record-keeping provisions. He was also ordered to pay a third-tier civil money penalty of \$500,000.

After an administrative trial and consideration of the record, Judge Bober found that Mr. Geman aided and abetted PMC's violations of antifraud provisions by making material misrepresentations and omissions with regard to the compensation PMC received in its wrapfee program and PMC's confirmation tickets. Judge Bober, however, found that PMC fulfilled its duty of best execution.

In addition, Judge Bober found that PMC, aided and abetted by Mr. Geman, failed to keep required records and did not notify the Commission of its failure to do so. (Initial Decision No. 112)

TRO AND ASSET FREEZE ENTERED AGAINST INSNET WORLD COMMUNICATIONS

The Commission announced the filing of a complaint on July 28 against Insnet World Communications, Inc., Frank Bravo, Jr., Jose Manuel Diaz-Salin, Scofield Berthelot, Jr. and SCB Resources, Inc., seeking an ex parte temporary restraining order, asset freeze and other relief. The Commission alleges that the defendants are engaged in ongoing fraudulent offers and sales of promissory notes issued by Insnet, the proceeds of which are purportedly used to purchase telephone time and distribute prepaid calling cards. The Commission alleged that, since October 1995, the defendants have raised at least \$4.8 million from approximately 216 investors in 38 states. Instead of using the funds as represented, the complaint alleges that approximately \$2.8 million of investor funds have been paid to the defendants. The complaint also states that funds from new investors are used to make interest payments and returns of principal to earlier investors.

The complaint also names Eduardo "Eddie" Grijalva, Bravo's nephew, as a relief defendant, seeking an asset freeze and disgorgement of the more than \$694,000 Grijalva allegedly received from Insnet. Honorable Kenneth Hoyt granted the <u>ex parte</u> relief sought by the Commission and set a preliminary injunction hearing for August 7, 1997. [SEC v.
