## INVESTMENT COMPANY ACT RELEASES

### FUNDMANAGER PORTFOLIOS

A notice has been issued giving interested persons until September 2, 1997, to request a hearing on an application filed by FundManager Portfolios for an order under Section 12(d)(1)(J) of the Investment Company Act that would exempt applicants from Section 12(d)(1)(F) of the Act. The order would permit each portfolio to offer its shares to the public with a sales load in excess of the 1.5% limit set forth in Section 12(d)(1)(F)(ii). (Rel. IC-22782 - August 7)

MUTUAL FUND VARIABLE ANNUITY TRUST, ET AL.

A notice has been issued giving interested persons until September 2, 1997, to request a hearing on an application filed by Mutual Fund Variable Annuity Trust (Trust), The Chase Manhattan Bank (Adviser) and certain life insurance companies and their separate accounts that do now or may in the future purchase shares of capital stock in the Trust (collectively, Applicants). Applicants seek exemptive relief to the extent necessary to permit shares of the Trust to be sold to and held by separate accounts funding variable annuity and variable life insurance contracts issued by both affiliated and unaffiliated life insurance companies and qualified pension and retirement plans outside the separate account context. ALLIANCE ALL-MARKET ADVANTAGE FUND, INC.

A notice has been issued giving interested persons until September 3, 1997, to request a hearing on an application filed by the Alliance All-Market Advantage Fund, Inc. for an order under Section 6(c) of the Investment Company Act that would grant an exemption from Section 19(b) of the Act and Rule 19b-1 under the Act. The order would permit applicant to make up to five distributions of long-term capital gains in any one taxable year, so long as it maintains in effect a distribution policy calling for quarterly distributions of a fixed percentage of its net asset value. ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The <u>National Association of Securities Dealers</u> filed Amendment No. 5 to a proposed rule change (SR-NASD-96-29) relating to the Allocation and Delegation of Authority by the NASD to NASD Regulation, Inc. and The Nasdaq Stock Market, Inc. The Commission is granting accelerated approval to the proposed rule change, as amended, until November 15, 1997. Publication of the proposal is expected to be made in the <u>Federal Register</u> during the week of August 11. (Rel. 34-38909)

APPROVAL OF PROPOSED RULE CHANGE
