COMMISSION ANNOUNCEMENTS

STAFF BULLETIN NO. 5 PUBLISHED

ENFORCEMENT PROCEEDINGS

PRELIMINARY INJUNCTION ENTERED AGAINST CIHACO INTERNATIONAL, INC., HARTMUT HAUSSECKER, BARTLEY CARSON HEALY, AND TANYA LLANES-TARVER, AND ASSET FREEZE IMPOSED ON BARTLEY CARSON HEALY

On October 6, the Honorable J. Thomas Greene, U.S. District Judge, entered a Preliminary Injunction against Cihaco International, Inc., Hartmut Haussecker, Bartley Carson Healy, and Tanya Llanes-Tarver, prohibiting them from selling unregistered securities or making misrepresentations in connection with the sale of securities. The judge also issued an order freezing Healy's assets and an order appointing Thomas J. O'Neal as receiver to liquidate Haussecker's previously frozen assets, including a partially finished house on Table Rock Lake near Branson, Missouri.

The Commission's August 27, 1997, complaint alleged that from January 1993 through January 1997, Cihaco, Haussecker, Healy, and Llanes-Tarver raised at least \$18 million through the fraudulent sale of unregistered securities from over 500 investors in a number of states including Utah, Idaho, Oregon, Missouri, and California. The securities involved were interests in investment pools to be managed by Haussecker, who was to invest in stocks, currencies, and other financial instruments with projected returns of from 17 percent to 60 percent per month. It was alleged that instead of investing the funds, most of the money was spent by Haussecker to support his lavish lifestyle. [SEC v. INVESTMENT COMPANY ACT RELEASES

SIERRA ASSET MANAGEMENT PORTFOLIOS, ET AL.

A notice has been issued giving interested persons until October 29 to request a hearing on an application filed under the Investment Company Act by Sierra Asset Management Portfolios, et al. Applicants request an order pursuant to Sections 6(c) and 17(b) of the Act granting relief from Section 17(a) and pursuant to Section 12(d)(1)(J) of the Act granting relief from Sections 12(d)(1)(A) and (C). The requested order amends a prior order to permit a "fund of funds" that is an open-end investment company to invest in an affiliated closed-end investment company. (Rel. IC-22842 - October 7)

LEVCO SERIES TRUST, ET AL.

An order has been issued pursuant to Section 6(c) of the Investment Company Act exempting LEVCO Series Trust (Trust) and John A. Levin & Co., Inc. (Levin) from the provisions of Sections 9(a), 13(a), 15(a) and 15(b) of the Act, and Rules 6e-2(b)(15) and 6e-3(T)(b)(15) The order provides for exemptions to the extent thereunder. necessary to permit shares of the Trust and any other open-end investment company that is designed to fund insurance products and for which Levin or any of its affiliates may serve as investment adviser, administrator, manager, principal underwriter or sponsor to be sold to and held by: (1) separate accounts funding variable annuity and variable life insurance contracts issued by both affiliated and unaffiliated life insurance companies; and (2) certain qualified pension and retirement plans outside of the separate account context. THE RESERVE PRIVATE EQUITY SERIES, ET AL.

An order has been issued on an application filed by The Reserve Private Equity Series, et al. under Section 6(c) of the Investment Company Act for an exemption from the provisions of Section 15(a) of the Act and Rule 18f-2. The order permits applicants to enter into and materially amend investment management agreements with the funds' subadvisers without shareholder approval. (Rel. IC-22844 -October 8)

FRANK RUSSELL INVESTMENT COMPANY, ET AL.

An order has been issued on an application filed by Frank Russell Investment Company, et al. under Section 12(d)(1)(J) of the

Investment Company Act exempting applicants from Sections 12(d)(1)(A) and (B) of the Act, under Sections 6(c) and 17(b) exempting applicants from Section 17(a), and under Section 17(d) of the Act and Rule 17d-1 under the Act to permit certain joint transactions. The order permits certain investment companies to purchase shares of affiliated investment companies for cash management purposes and would supersede a prior order. (Rel. IC-22845 - October 8)
