INTERNET IMPACT AND MICRO-CAP FRAUD HIGHLIGHT SEC MEETING; REGULATORY ISSUES ALSO ON CONSUMER AFFAIRS ADVISORY COMMITTEE AGENDA

The Commission's Consumer Affairs Advisory Committee will meet Tuesday, October 14, from 9:30 a.m. to 3:00 p.m. The meeting will be held in Room 1C30, at the Commission's headquarters building, 450 Fifth Street, N.W., Washington, D.C.

The meeting will cover micro-cap fraud initiatives, current SEC rulemaking, pending legislation, the Internet, and investor education efforts.

Chairman Levitt created the Consumer Affairs Advisory Committee in 1994 to advise the SEC about the interests and concerns of individual investors in the U.S. securities markets. Committee members include representatives of investor organizations, national consumer advocacy groups, corporations, financial services firms, shareholder relations specialists, and state securities regulators.

ENFORCEMENT PROCEEDINGS

STOCK PROMOTERS SETTLE ALLEGATIONS THAT THEY PAID KICKBACKS TO BROKERS

The Commission announced today that five stock promoters, previously charged with paying kickbacks to brokers for selling certain securities to their clients, have settled the charges against them. On September 27, 1996, the Commission filed a complaint in U.S. District Court for the Middle District of Florida alleging, among other things, that Steven DeCesare (DeCesare), Mark Missler (Missler) and three Florida corporations they controlled, Atlantic Capital Corporation (Atlantic), Wall Street Marketing, Inc. (Wall Street), and Pullman Publications, Inc. (Pullman), engaged in an 18-month fraudulent scheme in which they paid \$477,580 in bribes to seven stockbrokers to induce them to retail securities to the public.

DeCesare, Missler, Atlantic, Wall Street and Pullman consented, without admitting or denying the allegations in the complaint, to the issuance of a Final Judgment by Judge Patricia C. Fawsett of the United States District Court for the Middle District of Florida enjoining each from future violations of Sections 17(a) and 17(b) of the Securities Act of 1933 and Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5. Missler also consented to disgorge \$200,000 of the profits he received from the scheme. Disgorgement of the remainder of Missler's profits, and the profits of DeCesare, Atlantic, Wall Street and Pullman was waived, and civil penalties not imposed, based on each's demonstrated inability to [SEC v. The Commission granted accelerated approval to a proposed rule change (SR-NASD-97-72) filed by the <u>National Association of Securities Dealers</u> that extends until October 9, 1998, the pilot term of the Nasdaq International Service (Service) and the effectiveness of certain rules that are unique to the Service.
