INVESTMENT COMPANY ACT RELEASES

INVESTORS BANK & TRUST COMPANY, ET AL.

A notice has been issued giving interested persons until November 5, 1997, to request a hearing on an application filed by Investors Bank & Trust Company, Merrimac Funds, and Merrimac Master Portfolio for an order under Section 12(d)(1)(J) of the Investment Company Act that would grant an exemption from Section 12(d)(1), under Sections 6(c) and 17(b) of the Act that would grant an exemption from Section 17(a) of the Act, and under Rule 17d-1 to permit certain joint transactions in accordance with Section 17(d) of the Act and Rule 17d-1.
