### ENFORCEMENT PROCEEDINGS

### RONALD VIEMONT BARRED FROM SECURITIES INDUSTRY

The Commission entered an Order Making Findings and Imposing Remedial Sanctions pursuant to Sections 15(b)(6) and 19(h) of the Securities Exchange Act of 1934 (Exchange Act), against Ronald J. Viemont (Viemont), formerly a registered representative with two different broker-dealers registered with the Commission. Viemont consented to the Order, without admitting or denying the Commissions findings. The Order finds that Viemont was convicted of federal wire fraud in violation of 18 U.S.C. § 1343 and bars him from association with any broker, dealer, municipal securities dealer, investment adviser or investment company.

Specifically, the Order finds that, from at least August 1992 through at least August 1993, Viemont was a financial consultant to, and registered representative for, three public employee pension funds and one credit union. According to the Order, on January 17, 1996, Viemont was criminally convicted for committing wire fraud. The indictment upon which Viemont was convicted alleged that in August 1992 Viemont forged letters of authorization from the treasurer of two of the pension funds and improperly transferred \$200,000 out of their accounts. The indictment further stated that Viemont made misrepresentations and omissions to these clients, including telling them that their money had been used to purchase CD's and sending them false monthly investor reports which failed to disclose the misappropriations, and that in July 1993 unsuccessfully attempted to repay those funds by forging letters of authorization from the managers of the third pension fund and the credit union. According to the Order, Viemont was sentenced to 15 months imprisonment, fined \$4,000, and ordered to pay \$200,000 in restitution to the two defrauded pension funds. # CIVIL ACTION AGAINST HERNAN PEREZ

The Commission announced today that on October 17 Judge Salvador E. Casellas of the United States District Court for the District of Puerto Rico entered a preliminary injunction against defendant Hernan Jose Perez (Perez) and relief defendant Victor Mestres

Ayendez (Mestres) that, among other things, freezes their assets pending a hearing on a final injunction.

The Commission previously obtained a temporary restraining order and simultaneously filed a civil complaint alleging that from at least December 1995 through September 1997 Perez, while a broker at Clark Melvin Securities Corporation (Clark Melvin), a Hato Rey, Puerto Rico broker-dealer, misappropriated \$2.4 million from at least eight of Clark Melvin's customers and one other investor. According to the Commission's complaint, Perez misappropriated money on at least twenty-one separate occasions (i) by falsely endorsing checks written to or by his customers or (ii) by fraudulently inducing his customers to endorse checks to him. The complaint alleges that Perez lied to his customers by telling them that they needed to provide additional funds to cover margin debts, which did not in fact exist; by falsely telling them he would use their money to buy investments; and in at least one instance, by falsely telling an investor that he would use the funds to open an investment account for the investor. The Commission's complaint also alleges that some of the funds that Perez stole were deposited into a bank account in Mestres' name.

Perez, 49 years old, is a resident of Rio Piedras, Puerto Rico. Mestres operates Agencia Hipica, an off track betting service in Caparra, Puerto Rico.

The Commission's complaint charges Perez with violations of the antifraud provisions of the federal securities laws, specifically, Section 17(a) of the Securities Act of 1933 and Section 10(b) and Rule 10b-5 of the Securities Exchange Act of 1934 (15 U.S.C. § 77(q)(a); 15 U.S.C. § 78j(b) and 17 C.F.R. § 240.10b-5). Among other things, the Commission is seeking a permanent injunction against Perez prohibiting further violations of the antifraud provisions, and requests that Perez and Mestres disgorge their illgotten proceeds and that Perez pay a civil monetary penalty for his misconduct.
