#### COMMISSION ANNOUNCEMENTS

REPORT ON ADMINISTRATIVE PROCEEDINGS FOR THE PERIOD APRIL 1, 1997 THROUGH SEPTEMBER 30, 1997

## ENFORCEMENT PROCEEDINGS

DECISION BARRING MATT MATSON FROM PARTICIPATING IN THE OFFERING OF ANY PENNY STOCK

The decision of an administrative law judge concerning Matt Matson has become final. The order bars Matson from participating in the offering of any penny stock, including acting as a promoter, finder, consultant, agent, or other person who engages in actions with a broker, dealer, or issuer for the purposes of issuing or trading in any penny stock, or inducing or attempting to induce the purchase or sale of any penny stock.

The law judge imposed the bar based on a September 1996 permanent injunction entered, by consent, against Matson by the United States District Court for the Southern District of Florida (SEC v. Home Link Corp., et al., No. 96-6860-CIV-Gonzalez). The law judge found that Matson committed fraud in connection with the offer, purchase, and sale of the common stock of Home Link Corporation, a company of which he was the chief executive officer and sole director. The law judge specified that Matson, among other misconduct, made false statements to the financial press and the investing public regarding Home Link's business prospects and fraudulently altered Home Link's financial statements intending that they be published. The law judge concluded that "[t]he public interest demands a penny stock bar," based on the egregious nature of Matson's conduct, the high degree of scienter demonstrated by Matson, Matson's failure to

understand the gravity of his conduct, and the high likelihood that Matson again will commit penny stock fraud. (Rel. 34-39287)

MITCHELL HAMMER AND JOSEPH LETZELTER, JR. ENJOINED AND BARRED BY CONSENT

On October 23, Mitchell A. Hammer (Hammer) and Joseph Letzelter, Jr. (Letzelter), former employees of Sheffield Industries, Inc. (Sheffield), a bankrupt manufacturing company which had been based in Miami, Florida, by consent were permanently enjoined and barred from being officers and directors of public companies. The Commission's complaint, which was filed on July 25, 1997, alleged that between June 1991 and January 1993, Hammer, Sheffield's former CEO, and Letzelter, Sheffield's former controller, perpetrated a massive fraud on Sheffield's investors by maintaining two sets of books and by filing materially false financial reports with the Commission on Sheffield's behalf. #### RANDY KUHLMANN AND DAVID DARLING INDICTED

The Commission and the U.S. Attorney for the Southern District of California announced that on October 23 Randy S. Kuhlmann (Kuhlmann) and David S. Darling (Darling) were indicted by a federal grand jury for conspiracy, mail fraud, money laundering, and tax evasion. Kuhlmann and Darling were charged with conspiring to induce potential investors to participate in Amtel's sale-leaseback pay telephone program. Kuhlmann and Darling failed to disclose, among other things, that the pay telephones purchased by investors were encumbered property.

The criminal charges against Kuhlmann and Darling are based on the same activities alleged in the Commission's civil action filed on July 17, 1995, against Amtel Communications, Inc., Kuhlmann, and Darling. The Commission's complaint alleges, among other things, that the defendants raised about \$51.4 million from at least 3,750 investors through their fraudulent scheme.
