### COMMISSION ANNOUNCEMENTS

LETTER SIGNED BY CHAIRMAN LEVITT TO SECURITIES FIRMS REGARDING YEAR 2000 COMPLIANCE

The Commission has been active in communicating with the industry and with the public about the need to identify and address computer problems related to the approach of Year 2000. In late October 1997, the Chairman sent a letter to all registered transfer agents and broker-dealers. In this letter, the Chairman stressed how important it is that all securities firms be implementing plans and devoting adequate resources to modify their computer systems to make them ready for the Year 2000. The Chairman further encouraged firms to have all necessary modifications in place by the end of 1998 to allow for participation in industry-wide testing scheduled for 1999.

ORDER OF SUSPENSION OF TRADING ENTERED AGAINST ORLANDO SUPER CARD, INC.

The Commission announced the temporary suspension, pursuant to Section 12(k) of the Securities Exchange Act of 1934 (Exchange Act), of over-the-counter trading of the securities of Orlando Super Card, Inc. (Orlando Super Card) of Minnesota at 9:30 a.m. EST on November 3, 1997 and terminating at 11:59 p.m. EST on November 14, 1997. The Commission temporarily suspended trading in the securities of Orlando Super Card because of questions regarding (1) the trading and true value of the common stock of Orlando Super Card; and (2) the accuracy and adequacy of publicly disseminated information concerning Orlando Super Card's financial prospects. ## ENFORCEMENT PROCEEDINGS

BOND FLETCHER AND MEDIAJET, INC. CHARGED WITH AIDING AND ABETTING FRAUD BY EMANUEL PINEZ AND CENTENNIAL TECHNOLOGIES, INC.

The Commission announced today the filing of a complaint against Bond Dellapp Fletcher (Fletcher), the owner and president of Mediajet, Inc. (Mediajet), for aiding and abetting the financial fraud conducted by Emanuel Pinez (Pinez) and Centennial

Technologies, Inc. (Centennial). Mediajet, a manufacturer of font cartridges for laser printers and located in Beverly, Massachusetts, is also named as a defendant in the lawsuit. The complaint alleges that, from January 1996 through January 1997, Fletcher caused Mediajet to create false records and engage in several acts calculated to enable Centennial to include more than \$3 million in phony revenue in its reported financial results. According to the complaint, Fletcher engaged in this fraudulent conduct at the request of Pinez, the former CEO of Centennial. In return for the participation of Fletcher and Mediajet in Centennial's fraud, Pinez gave Fletcher at least 260,000 shares of Centennial common stock. Fletcher subsequently sold those shares for \$6,834,184. The complaint also alleges that Pinez made loans to Fletcher and Mediajet totaling \$190,000.

The complaint alleges that Fletcher and Mediajet aided and abetted Centennial's violations of several antifraud and reporting provisions of the securities laws. The Commission seeks a permanent injunction against further violations of those provisions by Fletcher and Mediajet, disgorgement of the defendants' ill-gotten gains and a civil penalty against Mediajet. # INVESTMENT COMPANY ACT RELEASES

ERRATA ISSUED CONCERNING FILING DATE FOR LEVCO SERIES TRUST, ET AL.

An Errata has been issued for the purpose of correcting the filing date on a notice concerning Levco Series Trust, et al. On September 9, 1997, a notice of filing of the application was issued (Rel. IC-22814) and on October 8, 1997, an order was issued (Rel. IC-22843). The filing date was recorded in the notice and order as April 18, 1997. The filing date should be corrected to read April 16, 1997. (Rel. IC-22843A - October 30)

FIRST AMERICAN INVESTMENT FUNDS, INC., ET AL.

A notice has been issued giving interested persons until November 20 to request a hearing on an application filed by First American Investment Funds, Inc., et al. for an order under Section 17(b) of the Investment Company Act exempting applicants from Section 17(a) of the Act. The order would permit certain series of three registered open-end investment companies to acquire all of the assets and liabilities of the series of another registered open-end investment company. Because of certain affiliations, applicants may not rely on Rule 17a-8 under the Act. (Rel. IC-22868 - October 30)

Beginning this month, the Commission will issue a single monthly notice of applications for deregistration under the Investment Company Act. The notice will be issued on the last Friday of each month. The notice will provide a short summary of each deregistration application and other relevant information. The new notice format is designed to be a more effective and efficient way to inform the public about deregistration applications. The Commission approved a proposed rule change (SR-NASD-97-26) filed by the <u>National Association of Securities Dealers</u> relating to an extension to March 27, 1998, and expansion of the pilot for the NASD's rule permitting market makers to display their actual quotation size to 150 stocks.
