ENFORCEMENT PROCEEDINGS

IN THE MATTER OF DICKINSON & CO. AND T. MARSHALL SWARTWOOD

On November 4, the Commission entered a settled order making findings, imposing remedial sanctions and cease and desist order against Dickinson & Co. and T. Marshall Swartwood. The Commission previously instituted contested administrative proceedings against Dickinson and Swartwood on May 28, 1997 (Rel. 33-7420). Order, the Commission finds that, in January 1992, Ronald Moskowitz, the former chief executive officer of Ferrofluidics Corporation, retained a self-employed analyst to write a research report about the company. On or about January 6, 1992, the analyst contacted Swartwood, the chairman of Dickinson, to discuss whether Dickinson would be willing to publish and distribute his Ferrofluidics research report. The Order finds that the analyst said that Ferrofluidics was paying him to write the report. Swartwood agreed to publish and distribute the report. The report was published by Dickinson on March 30, 1992, and an update, which was also paid for by Ferrofluidics, was published by Dickinson on July 12, 1992. Neither report disclosed that Ferrofluidics had paid for the reports or the amount of payment as required by Section 17(b) of the Securities Act of 1933.

The Order finds that Dickinson and Swartwood caused and willfully aided and abetted violations of Section 17(b) of the Securities Act. Without admitting or denying the allegations in the Order, Dickinson and Swartwood have each consented to cease and desist from committing or causing any violations or any future violations of Section 17(b) of the Securities Act and to pay civil money penalties of \$25,000 each. Dickinson and Swartwood also consented to be censured. (Rel. Nos. 33-7473; 34-39293; File No. 3-9321)

COMMISSION SUSTAINS NASD DISCIPLINARY ACTION AGAINST EXCEL FINANCIAL, INC., GARY BEYNON AND ROBERT SPERRY

The Commission has sustained the NASD's disciplinary action and sanctions against Excel Financial, Inc., of Salt Lake City, Utah, Gary Beynon, at the time its vice president, and Robert Sperry, at the time a half-owner and president.

The Commission agreed with the NASD's finding that applicants sold unregistered securities to non-accredited investors in violation of Section 5 of the Securities Act of 1933, and thereby violated Article III, Section 1 of the Rules of Fair Practice. The Commission also agreed with the NASD's finding that they prepared and distributed a misleading summary of the offering, in violation of Article III, Section 1 and 35 of the NASD Rules.

Excel participated in a private placement offering in reliance on an exemption from registration for limited offerings under Regulation D of the Securities Act. Applicants contacted selected customers before the specific details of the transaction were final and invited those interested to deposit funds into a third-party escrow account. The Commission stated that soliciting and receiving deposits into an escrow account prior to the release of the private placement memorandum constituted "sales" of securities and that the sales to 13 non-accredited investors were not exempt from Securities Act registration.

The Commission sustained the NASD's sanctions of censure, a \$10,000 fine, disgorgement, and the order that Excel pre-file advertising and sales literature with the NASD and obtain a "no objection" response prior to the materials' use. (Rel. 34-39296; File No. 3-9067)

ROBERT GERSH CHARGED WITH TEN COUNTS OF INTERSTATE TRANSPORTATION OF STOLEN PROPERTY FOR ROLE IN SECURITIES OFFERING

On October 23, 1997, the United States Attorney for the District of Massachusetts filed an Information charging that, between January 1990 and July 1995, Robert D. Gersh (Gersh) of Burlington, Massachusetts, misappropriated over \$4 million in investor funds that had been entrusted to two corporations under his control, Boston Municipal Securities, Inc. (BMS) and Devonshire Escrow and Transfer Corp. (Devonshire). Gersh was charged with ten counts of Interstate Transportation of Stolen Property. If convicted, Gersh faces a maximum sentence of ten years in prison for each count of the Information.

On November 29, 1997, the Commission filed a complaint against Gersh, BMS and Devonshire based on the same underlying facts contained in the Information. The complaint alleged that the defendants had conducted a fraudulent offering of \$14 million in COPs. On March 20, 1997, the Honorable Reginald C. Lindsay of the U.S. District Court for the District of Massachusetts enjoined Gersh, BMS and Devonshire from further violations of certain antifraud provisions of the securities laws. On April 1, 1997, the Commission barred Gersh from the securities industry. [U.S. v. Robert D. Gersh, USDC, D. MA, 97CR10277, RGS] (LR-15550)

INVESTMENT COMPANY ACT RELEASES

SIERRA ASSET MANAGEMENT PORTFOLIOS, ET AL.

An order has been issued on an application filed by Sierra Asset Management Portfolios, et al. under Sections 6(c) and 17(b) of the Investment Company Act exempting applicants from Section 17(a), and under Section 12(d)(1)(J) of the Investment Company Act exempting applicants from Sections 12(d)(1)(A) and (C) of the Act. The order permits a "fund of funds" that is an open-end investment company to invest in an affiliated closed-end investment company. (Rel. IC-22869 - October 31)

BLANCHARD FUNDS, ET AL.

An order has been issued on an application filed by Blanchard Funds, The Virtus Funds, Blanchard Precious Metals Fund, Inc. (collectively, Funds), and Virtus Capital Management, Inc. (Adviser) under Section 6(c) of the Investment Company Act for an exemption from Section 15(a) of the Act. Signet Banking Corporation, parent of the Adviser, has agreed to merge with and into First Union Corporation or a designated subsidiary. The indirect change in control of the Adviser will result in the assignment, and thus the termination, of the existing advisory contracts between the Funds and the Adviser. The order permits the implementation, without shareholder approval, of new investment advisory agreements for a period of up to 120 days following the date of the change in control of the Adviser (but in no event later than April 30, 1998). The order also permits the Adviser to receive all fees earned under the new investment advisory agreements following shareholder approval. (Rel. IC-22872 - November 3)

TRAVELERS GROUP INC., ET AL.

A notice has been issued giving interested persons until November 24 to request a hearing on an application filed by Travelers Group Inc., Smith Barney Holdings Inc., and Salomon Inc (Salomon) for an order under Section 6(c) of the Investment Company Act exempting applicants from Section 15(a) of the Act. The order would permit the implementation, without shareholder approval, of new investment advisory agreements between Salomon's investment advisory subsidiaries (Advisers) and various registered investment companies for a period of up to 150 days following consummation of a merger (but in no event later than June 9, 1998). The order also would permit the Advisers to receive all fees earned under the new investment advisory agreements following shareholder approval. (Rel. IC-22873 - November 3)

EOUUS II INCORPORATED

An order has been issued on an application filed by Equus II Incorporated under Section 61(a)(3)(B) of the Investment Company Act approving applicant's stock option plan for certain of its directors and the grant of certain stock options under the plan. (Rel. IC-22874 - November 4)

EVERGREEN TRUST, ET AL.

A notice has been issued giving interested persons until November 21 to request a hearing on an application filed by Evergreen Trust, et al. Applicants have requested an order pursuant to Sections 6(c) and 17(b) of the Investment Company Act requesting an exemption from Section 17(a) of the Act. The order would permit the reorganization and consolidation of certain registered open-end investment companies, and the conversion of certain common trust funds and collective investment funds into registered open-end investment companies. (Rel. IC-22875 - November 4)

SELF-REGULATORY ORGANIZATIONS

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

A proposed rule change (SR-CBOE-97-52) filed by the <u>Chicago Board Options Exchange</u> to include Martin Luther King, Jr. Day as an Exchange holiday has become immediately effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. Publication of the notice is expected in the <u>Federal Register</u> during the week of November 3. (Rel. 34-39289)

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change and amendments thereto submitted by the <u>National Association of Securities Dealers</u> (SR-NASD-95-63) relating to the rules governing broker-dealers operating on the premises of financial institutions. Publication of the notice is expected in the <u>Federal Register</u> during the week of November 10. (Rel. 34-39294)
