### ENFORCEMENT PROCEEDINGS

COMMISSION DENIES PETITION OF NASD REGULATION, INC. FOR RECONSIDERATION

The Commission has denied the petition of NASD Regulation, Inc. for reconsideration of the Commission's order remanding an NASD disciplinary proceeding for a determination of Toney L. Reed's financial ability to pay restitution.

In 1994, the Commission affirmed the NASD's findings that Reed had charged excessive markups in the sale of securities and had engaged in various registration, supervision, recordkeeping, and reporting violations. The Commission also sustained the NASD's sanctions, except for the restitution order, which it remanded because Reed had raised the issue of his financial inability to pay but had not had the opportunity to introduce certain additional evidence on the issue.

On remand, the NASD refused to consider evidence of Reed's financial ability to pay restitution. On review, the Commission vacated the NASD's order, and advised that, because Reed had raised the issue and because the result of a failure to pay would be revocation of Reed's registration, it regarded directing the NASD to consider Reed's financial ability to pay restitution as required by the Securities Exchange Act of 1934. That statute mandates that the Commission determine whether a sanction is excessive or oppressive when reviewing an NASD disciplinary action on appeal. NASD Regulation then filed for reconsideration.

In rejecting the petition for reconsideration, the Commission concluded that in the context of the NASD's current procedures (which authorize automatic revocation for nonpayment of restitution), the failure to consider Reed's claim of bona fide inability to pay in assessing sanctions renders those sanctions excessive and oppressive. ## APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change filed by the <u>National Association of Securities Dealers</u> (SR-NASD-97-60) relating to trading halts. Publication in the <u>Federal Register</u> is expected during the week of December 1. (Rel. 34-39366)

The Commission approved a proposed rule change filed by the <u>National Association of Securities Dealers</u> (SR-NASD-97-53) that would codify permissible uses of computer generated quote systems with respect to exchange-listed securities; eliminate the excess spread rule for

market makers in exchange-listed securities; reduce the minimum quotation size applicable to market makers in such securities to one unit of trading; extend exemptive provisions of the NASD's limit order protection rule to such securities; and reduce from 1000 to 100 the number of shares the Computer Assisted Execution System will execute automatically. Publication in the <u>Federal Register</u> is expected during the week of December 1. (Rel. 34-39367)

The Commission approved a proposed rule change filed by the Nasdaq Stock Market, Inc. (Nasdaq) (SR-NASD-97-51) that will amend the rules of the National Association of Securities Dealers to require Nasdaq issuers that offer a direct registration program to shareholders to participate in an electronic link with a securities depository registered under Section 17A of the Securities Exchange Act of 1934.
