RULES AND RELATED MATTERS

UPDATE OF REGISTRATION FORM TO REFLECT FEE RATE CHANGE FOR REGISTRATION OF CERTAIN INVESTMENT COMPANY SECURITIES

The Commission has issued a release updating the fee rate information in the instructions to Form 24F-2, the form under the Investment Company Act that prescribes the method by which certain investment companies calculate and pay registration fees on securities they issue. As of November 28, 1997, there is a new fee rate of \$295 per \$1,000,000 offered or sold (pro rated for amounts less than \$1,000,000). Registration fees under this new rate are calculated by multiplying the aggregate offering or sales amount by .000295. TECHNICAL AMENDMENTS TO RULE 2a-7 UNDER THE INVESTMENT COMPANY ACT

The Commission has issued a release adopting technical amendments to Rule 2a-7 under the Investment Company Act, the rule regulating money market funds. The Commission also adopted amendments to the advertising rules and forms applicable to money market funds to clarify how money market funds calculate current yield and represent short-term total return. ENFORCEMENT PROCEEDINGS

COMMISSION SUSTAINS NYSE DISCIPLINARY ACTION AGAINST GREGORY FABIO

The Commission has sustained New York Stock Exchange disciplinary action against Gregory Paul Fabio of Greenwich, Connecticut. The Exchange found that Fabio violated its rules when he engaged in discretionary trading in a customer's account without the customer's prior written authorization. The Exchange censured Fabio and suspended him for six weeks from membership and approved person

status, and from employment or association in any capacity with any Exchange member firm or organization.

Before the Commission, Fabio contested only the sanctions imposed. The Commission concluded that the Exchange's finding of violation was amply supported, and that the Exchange's sanctions did not impose an undue burden on competition and were neither excessive nor oppressive. The Commission found no support in the record for Fabio's claim that, in sanctioning Fabio, the Exchange considered misconduct other than that proven by the Exchange's prosecutorial staff. INVESTMENT COMPANY ACT RELEASES

JANUS INVESTMENT FUND, ET AL.

A notice has been issued giving interested persons until December 29 to request a hearing on an application filed by Janus Investment Fund, et al. for an order under Section 6(c) of the Investment Company Act granting an exemption from Sections 18(f) and 21(b) of the Act, under Section 12(d)(1)(J) of the Act granting an exemption from Section 12(d)(1) of the Act, under Sections 6(c) and 17(b) of the Act granting an exemption from Sections 17(a)(1) and 17(a)(3) of the Act, and under Section 17(d) of the Act and Rule 17d-1 under the Act to permit certain joint arrangements. The order would permit certain registered investment companies to participate in a joint lending and borrowing facility. (Rel. IC-22922 - December 2)

SELF-REGULATORY ORGANIZATIONS

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGES

A proposed rule change filed by the New York Stock Exchange extending the effectiveness of the pilot program for Allocation Policy and Procedures until January 16, 1998 (SR-NYSE-97-32) has become effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. Publication of the proposal is expected in the Federal Register during the week of December 1. (Rel. 34-39368)

A proposed amendment to the Options Price Reporting Authority (OPRA) Plan to revise allocation of revenues between OPRA's basic accounting center and OPRA's index option accounting center has become effective pursuant to Rule 11Aa3-2(c)(3)(i) of the Securities Exchange Act of 1934. Publication of the proposal is expected in the Federal Register during the week of December 1. (Rel. 34-39380)

PROPOSED RULE CHANGE

The Depository Trust Company filed a proposed rule change (SR-DTC-97-14) to amend DTC's procedures for running call lotteries for book-entry only issues of securities so that DTC will run the lottery using its participants' positions as of the close of business on the day DTC announces the lottery. Publication of the proposal is expected in the Federal Register during the week of December 1. (Rel. 34-39373)

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change submitted by the New York Stock Exchange (SR-NYSE-97-17) to amend the Exchange's wireless data communications initiatives. (Rel. 34-37379)
