COMMISSION ANNOUNCEMENT

CHAIRMAN ARTHUR LEVITT SENDS LETTERS TO REGISTERED UTILITY HOLDING COMPANIES REGARDING YEAR 2000 COMPLIANCE

Chairman Levitt recently sent a letter to all utility holding companies registered with the Commission regarding their computer systems' readiness for the Year 2000. In his letter, the Chairman stressed the importance of implementing necessary plans and devoting adequate resources to modify their information preparation for Year 2000 readiness. He further emphasized the "extremely serious consequences" if such appropriate preparation is Finally, the Chairman urged the registered holding companies to "make every effort . . . to keep [the SEC] and . . . other regulators apprised of all issues pertinent to Year 2000 preparation that may affect investors and consumers." Technology will play a critical role in the future success of registered utility holding companies. This letter is part of the Commission's ongoing communication with the industry to make a successful technological transition to the next millennium. (Press Rel. 97-109)

Applicants seek an order under Section 6(c) of the Investment Company Act granting exemptions from the provisions of Sections 9(a), 13(a), 15(a) and 15(b) of the Act and Rules 6e-2(b)(15) and 6e-3(T)(b)(15) thereunder to the extent necessary to permit shares of any current or future series of the Fund and shares of any other investment company that is designed to fund variable insurance products and for which the Adviser or any of affiliates may serve now or in the future as investment adviser, administrator, manager, principal underwriter or sponsor to be offered and sold to, and held by variable annuity and variable life insurance separate accounts of both affiliated and unaffiliated life insurance companies and qualified pension and retirement plans outside of the separate account context. HOLDING COMPANY ACT RELEASES

REQUEST FOR RECONSIDERATION OF RULE 58

The Commission has issued an order denying a request by the City Council of the City of New Orleans, Louisiana, for reconsideration of Rule 58, adopted by the Commission on February 14, 1997, under the Public Utility Holding Company Act, as amended. The order notes that the request for reconsideration raises no legal or factual issues that the Commission failed to consider before it adopted Rule 58 or that would alter its determination to adopt the rule. CONSOLIDATED NATURAL GAS CO., ET AL.

A notice has been issued giving interested persons until December 29 to request a hearing on a proposal by Consolidated Natural Gas Co. (CNG), a registered holding company, its wholly owned non-utility subsidiary, CNG Energy Services Corp. (Energy Services), and CNG Power Company (Power), a nonutility subsidiary company of Energy Services. The proposal would calls for Power to become the principal vehicle for CNG investments in exempt wholesale generators (EWGs); for Power to form intermediate companies to make EWG investments; for CNG, Energy Services, and Power to provide credit support of up to \$150 million through December 31, 2002, with respect to EWG investments; for Energy Services to provide services, construction or goods to EWGs; for Energy Services to contract with CNG companies to provide those services, construction and goods; and for CNG to change the par value of Energy Services common stock from

\$1.00 to \$10,000 and to increase the authorized shares from 4,000 to 50,000 shares. (Rel. 35-26790)

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGES

A proposed rule change filed by the <u>Chicago Board Options Exchange</u> to modify transaction fees for options on the Standard & Poor's 100 Stock Index (SR-CBOE-97-60) has become effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. Publication of the proposal is expected in the <u>Federal Register</u> during the week of December 8. (Rel. 34-39389)

A proposed rule change (SR-Phlx-97-48) filed by the <u>Philadelphia Stock Exchange</u> on November 5, 1997, to extend and amend the Exchange's Pilot Program for Equity and Index Option Specialist Enhanced Parity Splits has become immediately effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934.
