ENFORCEMENT PROCEEDINGS

JAMES TERRANO AND LYNN MICHL, CPA, ORDERED TO CEASE AND DESIST AND MICHL SUSPENDED FROM PRACTICE BEFORE THE COMMISSION

The Commission instituted and simultaneously settled cease and desist proceedings pursuant to Section 21C of the Securities Exchange Act of 1934 (Exchange Act) against James A. Terrano (James Terrano), former president and chief executive officer of Terrano Corporation (Terrano) and Lynn R. Michl, CPA (Michl), former chief financial officer of Terrano, and proceedings pursuant to Rule 102(e) of the Commission's Rules of Practice against Michl. James Terrano and Michl were ordered to cease and desist from, inter alia, committing or causing any violations of Sections 10(b), 13(a), 13(b)(2) and 13(b)(5) of the Exchange Act, and Rules 10b-5, 12b-20, 13a-1, 13a-13 and 13b2-1. The order also denies Michl the privilege of appearing or practicing before the Commission as an accountant with a right to reapply to resume such practice after five years. Terrano, now known as Dynamic Healthcare Technologies, Inc., was a publicly-held Lincoln, Nebraska, medical computer software company. The Commission found that, inter alia, James Terrano and Michl knew or should have known that Terrano filed periodic reports with the Commission for fiscal 1992 through 1994 containing materially misstated financial statements due to improper revenue recognition. H. THOMAS FEHN TEMPORARILY SUSPENDED FROM APPEARING OR PRACTICING AS AN ATTORNEY BEFORE THE COMMISSION

The Commission announced the entry of an Order instituting administrative proceedings and temporarily suspending H. Thomas Fehn from appearing or practicing before the Commission Pursuant to Rule 102(e) of the Commission's Rules of Practice (Order).

H. Thomas Fehn (Fehn), an attorney and a resident of Los Angeles, California, has thirty days after service of the Order to request a hearing regarding the Commission's issuance of a temporary suspension. If such a hearing is not requested, the suspension becomes permanent.

The Order contains findings that, on April 1, 1994, the U.S. District Court for the Southern District of Nevada found, after a bench trial, that Fehn committed aiding and abetting violations of certain of the antifraud and reporting provisions of the federal securities laws and issued an Order of Permanent Injunction (Injunctive Order) against Fehn. The Injunctive Order further stated that in late 1987, Fehn substantially assisted in the preparation of certain reports filed with the Commission by CTI Technical. Inc. (CTI), a Nevada corporation, that omitted to state numerous material facts concerning CTI and its initial public offering. In addition, the Injunctive Order stated that Fehn, in assisting in the preparation of these reports, "knew or closed his eyes to that which should have been obvious to a professional of his experience." The Order further found that Fehn appealed the Injunctive Order to the U.S. Court of Appeals for the Ninth Circuit, that the Ninth Circuit affirmed the Injunctive Order on October 9, 1996, and that the U.S. Supreme Court denied Fehn's petition for a writ of certiorari on October 6, 1997. ADMINISTRATIVE PROCEEDING INSTITUTED AND SETTLED AGAINST RENAISSANCE CAPITAL ADVISORS, INC. AND RICHARD FINE

The Commission announced that on December 22 it simultaneously instituted and settled public administrative proceedings pursuant to the Investment Advisers Act against Renaissance Capital Advisors, Inc. (Renaissance) and Richard N. Fine (Fine). Without admitting or denying the Commission's findings, Renaissance and Fine consented to the issuance of an Order that Fine and Renaissance be censured, pay civil penalties of \$10,000 each, cease and desist from violating Sections 206(1), 206(2), 206(4) and 204 of the Advisers Act and Rules 206(4)-4, 204-1, and 204-2 thereunder, and that Renaissance pay disgorgement of \$123,430.27 plus prejudgment interest, maintain revised soft dollar policies and procedures, and not solicit or accept new clients for 60 days.

Pursuant to the Order and Renaissance's and Fine's Offers of Settlement, the Commission found that from approximately February 1991 through January 1994, Renaissance, an investment adviser, and its president, Fine, failed to: disclose Renaissance's practice of using soft dollars for non-research expenses in its Form ADV; disclose Renaissance's precarious financial condition; and maintain substantiation for Renaissance's performance. TRO OBTAINED AGAINST CAPITAL ACQUISITIONS, INC., THE SOMERSET GROUP, INC., WAYNE NOTWELL AND CLEALON MANN

On December 23, the Commission obtained a TRO and assets freeze from the U.S. District Court for the District of Utah to halt a \$20 million Ponzi scheme. Named as defendants in the Commission's complaint are Capital Acquisitions, Inc., The Somerset Group, Inc., Wayne Notwell, and Clealon Mann, all of Salt Lake City, Utah.

The defendants have raised approximately \$20 million from at least 600 investors in several states through sales of three-year notes offering an annual "guaranteed" 20% return, for the purpose of conducting oil and gas drilling operations in Kansas and California. Investors were solicited by a network of sales agents, at least one of whom posted the offering on the Internet where it was detected by Commission staff.

The complaint alleges that the defendants have failed to disclose that income from its wells is insufficient to pay the guaranteed return and that the source of interest payments has been new investor funds. The complaint also alleges that the offering materials fail to disclose that: selling agents are receiving a total commission of approximately 46% on sales of the notes; the purported guarantor of the notes received 20% of the principal raised; and that the issuer has no control over the funds raised. COMMISSION OBTAINS TEMPORARY RESTRAINING ORDER AGAINST NICHOLAS ZAHAREAS, TUSCHNER & COMPANY, INC. AND JOHN TUSCHNER

Commission obtained a temporary restraining order (TRO) compelling Nicholas Zahareas, a U.S. citizen residing in Greece, to comply with a July 1993 Commission Order barring him from association with any broker or dealer and for violations and aiding and abetting violations of the broker-dealer association provisions of the federal securities laws. The Court entered a separate TRO against John Tuschner and Tuschner & Company, Inc., a Minneapolis based broker-dealer, for violations and aiding and abetting violations of the association provisions of the securities laws. Tuschner and Tuschner & Co. consented to the entry of the TRO without admitting or denying the allegations of the complaint. The complaint alleged that Zahareas wrongfully associated with Tuschner referring over 200 customers residing in Greece to & Co. by: Tuschner & Co.; directing trading; placing orders for over \$9 million worth of securities with Tuschner & Co.'s trader; determining the amount of commissions; and receiving up to 75% of those commissions through Relief Defendant Euroamerican Securities The complaint alleged that since at least February 1996, Tuschner knew of Zahareas' bar and permitted his wrongful association. The Court found, in the Zahareas TRO, that enforcement of Commission bar orders is crucial to protect investors and ensure the safety of the securities markets. A preliminary injunction hearing against Zahareas and another hearing against Tuschner and Tuschner & Co. are scheduled for January 1998. [SEC v. Nicholas A. SEC v. MILLENNIUM SOFTWARE SOLUTIONS, INC. AND MARK SHKOLIR

The Commission announced today that on December 18 the Honorable Denny Chin of the United States District Court for the Southern District of New York issued orders preliminarily enjoining

defendants Millennium Software Solutions, Inc. (Millennium), and its president, Mark Shkolir (Shkolir), from further violations of Section 17(a) of the Securities Act of 1933, and Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5, freezing Millennium's and Shkolir's assets, requiring Millennium and Shkolir to provide an accounting, and prohibiting the destruction of documents. Shkolir consented to the issuance of the order against him.

With the Commission's consent, the Court also stayed the Commission's action with respect to Shkolir pending resolution of a parallel criminal investigation being conducted by the United States Attorney's Office for the Southern District of New York.

In its complaint, filed on December 8, the Commission alleged that since at least November 1997, Millennium and Shkolir had raised at least \$200,000 by offering and selling Millennium common stock and warrants to investors while misrepresenting Millennium's financial condition and falsely stating that Charles Schwab & Co., a registered broker-dealer, was affiliated with the Millennium offering. COURT ORDERS PERMANENT INJUNCTION, DISGORGEMENT AND A PENALTY IN PRIME BANK SCHEME ON THE INTERNET

The Commission announced the entry of a final judgment against Renate Haag, d/b/a Haag + Partner, enjoining her from violations of Sections 5 and 17(a) of the Securities Act, Sections 15(a) and 10(b) of the Exchange Act, and Rule 10b-5 thereunder, and ordering her to pay disgorgement of \$4,355,400 plus prejudgment interest in the amount \$609,892.10, and a civil penalty of \$4,355,400, for a total of \$9,320,692.10. The Court entered the final judgment after Haag was defaulted.

The Commission's complaint alleges that Haag was the central figure in a fraudulent securities offering of so-called "prime bank instruments," that induced members of the public to invest over \$1 million in her programs by promising, in some cases, returns as high as 200% to 420% annually.

Additionally, Haag recently was sentenced to two years and ten months by the German criminal authorities in connection with her participation in a similar pyramid scheme in Germany. [SEC v. Gene Block, Individually and d/b/a Block Consulting Services, Renate Haag, Individually and d/b/a Haag + Partner, and Robert T. COURT GRANTS SEC'S REQUEST TO FREEZE ASSETS OF EMANUEL PINEZ, AND DETERMINES THAT LEHMAN BROTHERS FAILED TO ACT IN "GOOD FAITH" IN PLACING TLLEGAL TRADES FOR PINEZ

The Commission announced that the Honorable Patti B. Saris of the U.S. District Court for the District of Massachusetts granted the Commission's motion to freeze the assets of Emanuel Pinez (Pinez), the former chief executive officer of Centennial Technologies, Inc. (Centennial). Most significantly, the preliminary injunction prohibits Lehman Brothers, Inc. (Lehman) from taking over \$4.69 million of illicit profits from Pinez's alleged insider trading in options on Centennial common stock on February 7, 1997. The Commission previously had amended its complaint against Pinez by adding Lehman as a relief defendant.

Lehman had asserted a claim against the proceeds, seeking repayment for margin loans that Lehman made to Pinez under a margin agreement. The Commission sought to freeze Pinez's assets for disgorgement to investors who were defrauded by Pinez's alleged insider trading. The Court found that Lehman had "actual knowledge of highly suspicious circumstances" relating to Pinez's trades, and therefore was not a "bona fide" purchaser entitled to the proceeds of those transactions. INVESTMENT COMPANY ACT RELEASES

FIRST AMERICAN FUNDS, INC., ET AL.

An order has been issued on an application filed by First American Funds, Inc., et al. under Section 12(d)(1)(J) of the Investment Company Act for an exemption from Sections 12(d)(1)(A) and (B) of the Act, under Sections 6(c) and 17(b) of the Act for an exemption from Section 17(a) of the Act, and under Rule 17d-1 under the Act permitting certain joint transactions in accordance with Section 17(d) of the Act and Rule 17d-1. The order supersedes a prior order to permit certain registered investment companies to purchase shares of money market funds advised by the same adviser for cash management purposes. The order also amends a prior order permitting a fund of funds to purchase shares of certain investment companies in the same group of investment companies in excess of the limits of Section 12(d)(1). (Rel. IC-22950 - December 23)

HOLDING COMPANY ACT RELEASES

COLUMBIA GAS SYSTEM, INC., ET AL.

An order has been issued authorizing Columbia Gas System, Inc. (Columbia), a registered holding company, and certain of its wholly owned subsidiaries (together, System), through December 31, 2003, (a) to increase the System's short-term financing authority to an amount not to exceed \$2 billion at any one time outstanding; (b) to continue the System's money pool transactions; and (c) for four of Columbia's wholly owned utility subsidiaries, Columbia Gas of Maryland, Inc., Columbia Gas of Kentucky, Inc., Columbia Gas of Ohio, Inc., and Columbia Gas of Pennsylvania, Inc. to issue to Columbia, and for Columbia to acquire, short-term debt securities. (Rel. 35-26798)

MONONGAHELA POWER COMPANY, ET AL.

An order has been issued authorizing a proposal by Monongahela Power Company and The Potomac Edison Company (Declarants), each a wholly owned subsidiary company of Allegheny Energy, Inc., a registered holding company. Declarants have been authorized, through December 31, 2002, to issue notes to support the contemporaneous issuance of an aggregate principal amount of \$10.56 million of pollution control revenue bonds by The Greene County Industrial Authority, Greene County, Pennsylvania. GPU, INC., ET AL.

A supplemental order has been issued extending existing authorizations of GPU, Inc., a registered holding company (GPU), to invest in exempt wholesale generators and foreign utility companies and to guarantee obligations of those entities in an aggregate amount not to exceed 100% of GPU's consolidated retained earnings, through December 31, 2000. The supplemental order also authorizes certain nonutility subsidiaries of GPU to guarantee or assume liabilities of securities issued by, or other obligations of, their subsidiaries in an aggregate amount not to exceed \$1 billion, through December 31, 2000. GPU, INC., ET AL.

A supplemental order has been issued authorizing a proposal by GPU, Inc. (GPU), a registered holding company, and Jersey Central Power & Light Company (JCP&L), Metropolitan Edison Company (Met-Ed), and Pennsylvania Electric Company (Penelec), each an electric public utility subsidiary of GPU. GPU, JCP&L, Met-Ed, and Penelec propose to extend to December 31, 2000 the time period during which they may issue, sell, and renew certain short-term borrowings authorized by prior Commission orders. (Rel. 35-26801)

GPU, INC., AND GPU INTERNATIONAL, INC.

A supplemental order has been issued authorizing a proposal by GPU, Inc. (GPU), a registered holding company, and GPU International, (GPU International), a nonutility subsidiary (Applicants). Applicants propose to: expand the purposes for which GPU may enter into quarantees, support instruments, and bank letters of credit reimbursement agreements or similar financial instruments or undertakings (Guarantees) on behalf of GPU International to include Guarantees of obligations of GPU International or a subsidiary of GPU International (GPUI Subsidiary); increase to \$150 million the aggregate principal amount of Guarantees which GPU International may have outstanding and to expand the purposes for which GPU International may enter into Guarantees to include quarantees of the obligations of GPUI Subsidiaries; extend until December 31, 2000 the period during which GPU and GPU International may enter into Guarantees; and to permit any GPUI Subsidiary which is not an exempt wholesale generator or foreign utility company to guarantee the obligations of their subsidiaries through December 31, 2000 in an amount not to exceed \$150 million. SELF REGULATORY ORGANIZATIONS

APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change submitted by the <u>Philadelphia Stock Exchange</u> (SR-PHLX-97-39) relating to changes in Insider Trading and Securities Fraud Enforcement Act Rules. (Rel. 34-39468)

The Commission approved a proposed rule change (SR-CBOE-97-36) submitted by the <u>Chicago Board Options Exchange</u> to eliminate the 20% and 50% fixed tests from CBOE rules governing the halting and resumption of trading in index options. (Rel. 34-39480)

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission granted accelerated approval to a proposed rule change submitted by the <u>Pacific Exchange</u> (SR-PCX-97-43) relating to its specialist evaluation program. (Rel. 34-39477)

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGES

A proposed rule change filed by the <u>NASD Regulation</u>, <u>Inc.</u> (SR-NASD-97-85) relating to the issuance of an interpretive letter concerning NASD Rule 2460 has become effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. Publication of the proposal is expected in the <u>Federal Register</u> during the week of December 29. (Rel. 34-39478)

The Chicago Board Options Exchange filed a notice of filing and immediate effectiveness of a proposed rule change (SR-CBOE-97-61) to delete any specific references to a particular Floor Procedure Committee or Market Performance Committee, add the term appropriate to all references that currently relate to these committees, and make other conforming changes. Publication of the notice in the Federal Register is expected during the December 29. (Rel. 34-39479)

A proposed rule change filed by the <u>National Association of Securities Dealers</u> to reclassify 544 NNM securities into appropriate tier sizes for purposes of determining the maximum order size for a particular security eligible for execution through Nasdaq's Small Order Execution System (SOES) (SR-NASD-97-86) has become effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. Publication of the proposal is expected in the <u>Federal Register</u> during the week of December 29. (Rel. 34-39482)

PROPOSED RULE CHANGE

The <u>Philadelphia Stock Exchange</u> filed Amendment No. 2 to its proposed rule change (SR-Phlx-96-14) to implement a daily preopening order matching session for the execution of large-sized stock orders on a volume weight average price basis. Publication of the proposal is expected in the <u>Federal Register</u> during the week of December 29. (Rel. 34-39481)

DELISTINGS GRANTED

An order has been issued granting the application of the <u>New York Stock Exchange</u> to strike from listing and registration Regency Health Services, Inc., Common Stock, \$.01 Par Value. (Rel. 34-39475)

An order has been issued granting the application of the <u>New York Stock Exchange</u> to strike from listing and registration Graphic Industries, Inc., Common Stock, \$0.10 Par Value. (Rel. 34-39476)
