ENFORCEMENT PROCEEDINGS

EUGENE BILOTTI CONSENTED TO CEASE AND DESIST ORDER AND REMEDIAL SANCTIONS

The Commission announced that on December 23 it instituted public administrative proceedings against Eugene Bilotti (Bilotti). The Commission found that Bilotti willfully aided and abetted, and caused a violation of Sections 206(1) and 206(2) of the Investment Advisers Act by the Adviser, by recommending warrants in Eva-Health, USA, Inc. as investments to clients of the Adviser without having a reasonable, independent basis for that recommendation and that he willfully committed and caused violations of Sections 5(a) and 5(c) of the Securities Act of 1933 by selling unregistered warrants when no exemption from registration was available.

Bilotti consented to an administrative order to be entered against him that ordered him to cease and desist from committing the violations noted above, that suspended him from association with any broker, dealer, investment adviser, investment company or municipal securities dealer for a period of six months and ordered him to pay disgorgement and prejudgment interest in the amount of \$31,251.77 and a penalty in the amount of \$10,000. IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

The <u>National Association of Securities Dealers</u> filed an immediately effective rule change (SR-NASD-97-90) under Section 19(b)(3)(A) of the Exchange Act, amending the effective date of its corporate governance documents to coincide with the annual meeting of the NASD in January 1988 instead of the first meeting of the NASD Board of Governors in January 1998.
