## COMMISSION ANNOUNCEMENTS

SEC ORDERS DISTRIBUTION OF DISGORGEMENT FUND IN THE MATTER OF ELLIOT ROSENBERG, JACK GILBERT, HOWARD CAPLAN, GERALD PERLMUTAR, AND DOUGLAS MANSFIELD

The Commission today announced the entry of an Order Directing Distribution of Disgorgement Fund in the Matter of Elliot B. Rosenberg, Jack A. Gilbert, Howard M. Caplan, Gerald J. Perlmutar and Douglas H. Mansfield (the respondents). The Order directs that the \$435,000 disgorged by the respondents be distributed to approved claimants on a pro rata basis, in accordance with the Division of Enforcement's recommendation.

The Commission had ordered disgorgement and other remedial sanctions in its Order Instituting Proceedings Pursuant to Section 8A of the Securities Act of 1933 and Section 15(b)(6) of the Securities Exchange Act of 1934, Making Findings and Imposing Sanctions and Cease and Desist Orders. That action arose from a scheme to manipulate the prices for shares of Multireal Properties, Inc. and Delicorp Foodservice, Inc. See in the Matter of Elliot B. Rosenberg, Jack A. Gilbert, Howard M. Capian, Gerald J. Perlmutar and Douglas H. Mansfield, Admin. Proc. File No. 3-8703 (May 25, 1995). (Rels. 33-7492; 34-39501)

# PUBLICATION OF REGULATORY FLEXIBILITY ACT RULE REVIEW SCHEDULE

## INVESTMENT COMPANY ACT RELEASES

### FEDERATED INDEX TRUST

An order has been issued on an application filed by Federated Index Trust and ANB Investment Management and Trust Company (Subadviser) under Section 6(c) of the Investment Company Act for an exemption from Section 15(a) of the Act. The order permits the implementation, without shareholder approval, of a new investment advisory agreement for a period of up to 120 days following the date of a change in control of the Subadviser (but in no event later than May 30, 1998). The order also permits the Subadviser to receive all fees earned under the new investment sub-advisory agreement following shareholder approval. (Rel. IC-22977 - December 29)

DIAMONDS TRUST, DJIA TRUST RECEIPTS SERIES, PDR SERVICES CORPORATION AND ALPS MUTUAL FUNDS, INC.

An order has been issued on an application filed by Diamonds Trust, DJIA Trust Receipts Series (Trust), PDR Services Corporation (Sponsor) and ALPS Mutual Funds, Inc. under Section 6(c) of the Investment Company Act for an exemption from Sections 4(2), 14(a), 22(d), 24(d) and 26(a)(2)(C) of the Act and Rule 22c-1 under the Act, under Sections 6(c) and 17(b) of the Act for an exemption from Section 17(a) of the Act, and under Rule 17d-1 under the Act to permit certain joint transactions. The order (i) permits the Trust, a unit investment trust whose portfolio will consist of the component stocks of the Dow Jones Industrial Average, to issue nonredeemable securities (DJIA Trust Receipts); (ii) permits secondary market transactions in DJIA Trust Receipts at negotiated prices; (iii) permits dealers to sell DJIA Trust Receipts to purchasers in the secondary market unaccompanied by a prospectus, when prospectus delivery is not required by the Securities Act of 1933; (iv) permits certain expenses associated with the creation and maintenance of the Trust to be borne by the Trust rather than the Sponsor; (v) exempts the Sponsor from the Act's requirement that it purchase, or place with others, \$100,000 worth of DJIA Trust Receipts; (vi) permits affiliated persons of the Trust to deposit securities into and receive securities from the Trust in connection with the purchase and redemption of DJIA Trust Receipts; and (vii) permits the Trust to reimburse the Sponsor and/or the American Stock Exchange, Inc. for payment of an annual licensing fee to Dow Jones & Company, Inc. ### HOLDING COMPANY ACT RELEASE

### NATIONAL FUEL GAS

A notice has been issued giving interested persons until January 22,

1998 to request a hearing on a proposal by National Fuel Gas Company (NFG), a gas registered holding company, to amend its certificate of incorporation, subject to shareholder approval, to increase the number of authorized shares of common stock from 100,000,000 to 200,000,000 shares, eliminate all existing shares of authorized but unissued preferred stock and authorize 10,000,000 shares of a new class of preferred stock. An order has been issued authorizing NFG's solicitation of proxies to approve these amendments. (Rel. 35-26805)


