ENFORCEMENT PROCEEDINGS

MITCHELL COMMUNICATIONS CORPORATION PERMANENTLY ENJOINED AND ORDERED TO DISGORGE \$1,059,325; HOWARD THOMPSON PERMANENTLY ENJOINED AND ORDERED TO DISGORGE \$96,000

The Commission announced that on December 21 the Honorable William C. O'Kelley, United States District Judge for the Northern District of Georgia entered an order of permanent injunction against Mitchell Communications Corporation (Mitchell) of Atlanta, Georgia and ordered it to disgorge \$1,059,325 in ill-gotten gains, along with prejudgment interest. In a separate order, Judge O'Kelley permanently enjoined defendant Howard L. Thompson and ordered him to disgorge \$96,000 in ill-gotten gains, along with prejudgment interest.

The Commission's complaint alleged fraud against Mitchell in the offer and sale of securities in the form of interests in four wireless cable ventures. The Commission alleged that Mitchell Communications Corporation solicited investments in the partnerships by interstate telephone solicitations and follow-up mailings of offering documents. Mitchell fraudulently misrepresented the number of wireless cable channels acquired in the ventures and that the proceeds of the offerings were being spent for purposes undisclosed to investors. The Commission alleged that Thompson was an account representative for Mitchell who solicited purchasers of units in one of the wireless cable ventures, and engaged in business as a broker/dealer while not registered with the Commission. PERMANENT INJUNCTION AND OTHER ANCILLARY RELIEF ENTERED AGAINST FRANK CUSTABLE, JR. AND F.C. FINANCIAL CORPORATION

The Commission announced that on December 22 Judge Nordberg of the U.S. District Court for the Northern District of Illinois entered an Agreed

Order by consent against Frank J. Custable, Jr. (Custable) and F.C. Financial Corporation (FCF), a company owned, managed and operated by Custable. The Order permanently enjoins Custable and FCF from violating the antifraud provisions of the federal securities laws and, among other things, requires them to pay \$324,970.42 in disgorgement, requires them to pay \$30,000 for repair work necessary to preserve certain investors' collateral and lifts the freeze on their assets. Additionally, the Court set a briefing schedule for the Commission's Motion for an Assessment of Prejudgment Interest and Civil Penalties. The Commission's complaint and amended complaint, filed on June 20, 1994 and July 11, 1994, respectively, alleged that from at least June 1992 to July 11, 1994, the defendants offered and sold securities in the form of mortgage notes, secured by real property or personal property, and limited partnership interests in such notes, thereby raising at least \$1.8 million from at least 89 investors. The amended complaint further alleged that the defendants misrepresented and omitted to state material facts regarding, among other things, the nature, liquidity and risks of the investment. [SEC v. COMPLAINT FILED AGAINST DIGITRAN SYSTEMS, INC., DONALD GALLENT AND JAMES BRYAN

On December 29 the Commission filed a complaint in the U.S. District Court for the District of Utah against Digitran Systems, Inc., a Delaware corporation based in Logan, Utah, Donald G. Gallent and James R. Bryan. During the period relevant to the complaint, Gallent was the president and director, and Bryan was the chief financial officer of Digitran.

The Commission's complaint alleges violations of federal securities laws by Digitran, Gallent, and Bryan regarding antifraud, periodic reporting, accounting record keeping, internal accounting controls and representations to auditors.

The complaint alleges that Digitran improperly recognized revenues relating to sales of computerized simulators for five consecutive quarters during 1992 and 1993. The amount of revenue for those periods which was allegedly recognized improperly ranged from 46 percent to 93 percent of total revenues. It is also alleged that the defendants deceived Digitran's auditors in connection with an audit of the company's financial statements for the year ended April 30, 1992.

Finally, the complaint alleges that Gallent and Bryan sold Digitran stock while in possession of material, nonpublic information regarding Digitran's financial condition and operations, and that such sales constituted insider trading in violation of the federal securities laws. INVESTMENT COMPANY ACT RELEASES

AVESTA TRUST, ET AL.

A notice has been issued giving interested persons until January 30 to request a hearing on an application filed by AVESTA Trust, et al. for an order under Section 17(d) of the Investment Company Act and Rule 17d-1 thereunder. The order would permit series of AVESTA Trust and other investment companies that are advised by Texas Commerce Bank, N.A. or any entity controlling, controlled by, or under common control with Texas Commerce Bank to pool their uninvested cash balances and deposit the balances into one or more joint accounts. Cash balances in the joint accounts would be invested in short-term repurchase agreements. (Rel. IC-20817 - January 4)

KIDDER, PEABODY INVESTMENT TRUST, ET AL.

A notice has been issued giving interested persons until January 26 to request a hearing on an application filed by Kidder, Peabody Investment Trust, et al. for an order under Section 6(c) of the Investment Company Act exempting applicants from Section 15(a) of the Act. Paine Webber Group Inc. has agreed to purchase the investment advisory business of The transaction will result in the Kidder, Peabody Group Inc. assignment, and thus the termination, of existing investment advisory and subadvisory contracts of the applicant investment companies. The order will permit the implementation, without shareholder approval, of interim investment advisory and subadvisory contracts, during a period of up to 120 days following the closing of the transaction. also will permit the applicant investment advisers to receive from the applicant investment companies fees earned under the interim investment advisory contracts following approval by the investment companies! shareholders. PAINEWEBBER INCORPORATED, ET AL.

An order has been issued on an application filed by PaineWebber Incorporated, et al. under Section 6(c) of the Investment Company Act granting exemptions from Sections 2(a)(32), 2(a)(35), 22(c), 22(d), and 26(a)(2)(C) of the Act and Rule 22c-1 thereunder, and pursuant to Section 11(a) amending two prior orders that granted applicants relief from Section 11(c). The prior orders allow applicants to exchange trust units having deferred sales charges and to exchange units of a terminating series of a trust for units of the next available series of that trust. The requested order allows applicants to impose sales charges on a deferred basis and waive the deferred sales charge in certain cases. (Rel. IC-20819 - January 4)

PORTICO FUNDS, INC.

An order has been issued under Section 6(c) of the Act exempting Portico Funds, Inc. from Sections 13(a)(2), 17(a)(1), 18(f)(1), 22(f), and 22(g) of the Act and Rule 2a-7 thereunder and pursuant to Section 17(d) of the Act and Rule 17d-1 thereunder. The order permits applicant to enter into deferred compensation agreements with certain of its directors. (Rel. IC-20820 - January 4)

AIM EQUITY FUNDS, INC., ET AL.

A conditional order has been issued under Section 17(d) of the Investment Company Act and Rule 17d-1 thereunder. The order permits applicants to invest jointly in repurchase agreements with remaining maturities not to exceed 60 days and certain other short-term money market instruments with remaining maturities not to exceed 90 days. (Rel. IC-20821 - January 4)
