#### COMMISSION ANNOUNCEMENTS

HOUSE COMMITTEE ON COMMERCE TO HOLD A HEARING

The House Committee on Commerce will hold a hearing on Thursday, January 12, 1995, at 9:30 a.m. in Room 2123 of the Rayburn House Office Building concerning Developments in Municipal Financial Disclosure. The Commission witnesses at this hearing will be Chairman Levitt and Commissioner Roberts.

#### ENFORCEMENT PROCEEDINGS

PROCEEDINGS INSTITUTED AGAINST SHEER ASSET MANAGEMENT, INC. AND ITS PRESIDENT FOR FAILURE TO DISCLOSE DIRECTED BROKERAGE ARRANGEMENT

The Commission announced that on January 3 it simultaneously instituted and settled an administrative proceeding and cease-and-desist proceeding, pursuant to Section 203(e) and (k) of the Investment Advisers Act of 1940 (Advisers Act) against Sheer Asset Management, Inc. (SAM), a registered investment adviser, and a cease-and-desist proceeding, pursuant to Section 203(k) of the Advisers Act, against its president, Arthur Sheer (Sheer). SAM and Sheer consented to the issuance of the Order, without admitting or denying the Commission's findings.

On the basis of the Order and SAM's and Sheer's Offers of Settlement, the Commission found that, from approximately March 1991 through April 1993, SAM and Sheer failed to disclose in SAM's Form ADV that SAM had an agreement with a broker-dealer to direct \$50,000 worth of client brokerage annually for three years. Pursuant to the agreement, the broker-dealer agreed to provide research and research related services to SAM and agreed to relinquish its rights to SAM's trade name and client relationships. The Commission's Order directs that SAM and Sheer cease and desist from further violations of Section 207 of the Advisers Act and requires SAM to pay a \$10,000 penalty and comply with certain undertakings. # INVESTMENT COMPANY ACT RELEASES

EQUITABLE VARIABLE LIFE INSURANCE COMPANY, ET AL.

An order has been issued pursuant to Section 6(c) of the Investment Company Act exempting Equitable Variable Life Insurance Company, Separate Account FP of Equitable Variable Life Insurance Company and Equico Securities, Inc. (Applicants) from the provisions of Section 27(a)(3) of the Act and Rule 6e-3(T)(b)(13)(ii), 6e-3(T)(d)(1)(ii)(A)and 6e-3(T)(d)(2)(i) thereunder. The order provides exemptions to the extent necessary to permit Applicants to issue flexible premium variable life insurance contracts that provide for a higher contingent deferred sales charge percentage to be deducted following certain face amount increases. (Rel. IC-20822 - January 6)

CROFT-LEOMINSTER INCOME FUND, ET AL.

A notice has been issued giving interested persons until February 3 to request a hearing on an application filed by Croft-Leominster Income Fund, et al. for an order under Section 17(b) of the Investment Company Act that would exempt applicants from Section 17(a) of the Act. The order would permit the exchange of shares of the Fund for portfolio securities of a limited partnership. Thereafter, the partnership would dissolve and distribute the shares it received in the exchange <u>pro rata</u> to its partners. (Rel. IC-20823 - January 9)

# HOLDING COMPANY ACT RELEASES

APPALACHIAN POWER COMPANY ET AL.

A notice has been issued giving interested persons until January 30 to request a hearing on a proposal by Appalachian Power Company (APCO), a public utility subsidiary company of American Electric Power Company, a registered holding company, and Kanawha Valley Power Company (KVPCO), a wholly owned subsidiary of APCo. APCo proposes to acquire all of the assets and assume all of the liabilities of KVPCo in a merger in which APCO would be the surviving corporation. (Rel. 35-26214)

### GENERAL PUBLIC UTILITIES CORPORATION, ET AL.

A notice has been issued giving interested persons until January 30 to request a hearing on a proposal by General Public Utilities Corporation (GPU), a registered holding company, and Energy Initiatives, Inc., a non-utility subsidiary of GPU, to invest from time to time through January 31, 2002, up to \$10 million as a limited partner in funds which invest in companies commercializing electrotechnologies and renewable energy technologies.
