COMMISSION ANNOUNCEMENTS

CARREL APPLICATIONS NOW BEING ACCEPTED

Pursuant to the rules of the Commission's Public Reference Room, applications for the January allocation of carrels and telephone privileges for recognized user organizations (information dissemination companies) are now being accepted. Application forms are available in the Public Reference Room. Information dissemination companies that are unable to pick up forms in Washington may submit applications by writing to Stephen L. McConnell, Branch Chief, Public Reference, Securities and Exchange Commission, Room 1024, Mail Stop 1-2, 450 Fifth Street, N.W., Washington, D.C. 20549. Applications must include: a brief description of the business, business address and telephone number, the name of a person who will serve as on-site contact in the Room, and the names of all persons who work everyday in the Room, number of employees assigned to research/sales of SEC filings, regardless of work location, and number of carrels requested. Applicants may also submit a supplemental statement in support of their request for carrels/telephone privileges. The applications must be certified and signed by a responsible company official, and submitted by the close of business January 27, 1995. in the past, the assignment of carrels/telephone privileges is discretionary. The Commission intends to continue to reserve carrels for the general public.

ENFORCEMENT PROCEEDINGS

ADMINISTRATIVE PROCEEDINGS PURSUANT TO RULE 2(e) INSTITUTED AGAINST RONALD SHERRY, C.P.A

On January 11, the Commission instituted administrative proceedings pursuant to Rule 2(e) of the Commission's Rules of Practice against Ronald G. Sherry, a former Chief Financial Officer and director of Accuhealth. Inc. Simultaneously with the institution of proceedings, the Commission accepted Sherry's Offer of Settlement in which he consented to the issuance of the order, without admitting or denying the findings therein except to the finding that he was permanently enjoined from violating certain provisions of the federal securities laws, that permanently denies him the privilege of appearing or practicing before the Commission as an accountant. The Commission imposed this sanction and made its findings based upon a permanent injunction that was entered against Sherry, by consent, on December 2, 1994 by the United States District Court for the Southern District of New York enjoining Sherry from violating Sections 10(b) and 13(b)(5) of the Exchange Act and Rules 10b-5, 13b2-1 and 13b2-2 thereunder. FINAL JUDGMENTS ENTERED AGAINST KENNETH ROTH AND RONALD SHERRY

The Commission announced that on December 2, 1994 the United States District Court for the Southern District of New York entered Final Judgments of Permanent Injunction and Other Equitable Relief against Kenneth Roth and Ronald G. Sherry, former officers and directors of Accuhealth, Inc. Both Sherry and Roth consented to the entry of the Final Judgments without admitting or denying the allegations in the Commission's complaint, which was filed on September 8, 1994. The Final Judgment as to Roth permanently enjoins him from violating Section 17(a) of the Securities Act and Section 10(b) of the Exchange Act and Rule 10b-5 thereunder; and permanently bars him from serving as an officer or director of a public company. The Final Judgment notes the appropriateness of a penalty in this case but does not impose one based upon Roth's representations in sworn financial statements.

The Final Judgment as to Sherry, a former Chief Financial Officer of Accuhealth, permanently enjoins him from violating Sections 10(b) and 13(b)(5) of the Exchange Act and Rules 10b-5, 13b2-1 and 13b2-2 thereunder; permanently bars him from serving as an officer or director of a public company; and orders him to pay a \$15,000 civil penalty.
