# CHANGE IN THE MEETING: CANCELLATION

The closed meeting scheduled for Friday, February 10, 1995, at 2:00 p.m., was cancelled.

# LITIGATION ANALYSIS UNIT ESTABLISHED

Simon M. Lorne, the General Counsel of the Commission, has issued a statement in connection with the establishment of a Litigation Analysis Unit within the Office of the General Counsel.

The new Litigation Analysis Unit will expand the Commission's <u>amicus</u> <u>curiae</u> participation at the trial court level in selected cases. The Commission believes that it is important to participate at the trial court level because many of the current concerns regarding abuses in securities litigation relate to the dynamics of the trial court process. Greater participation at the trial court level will place the Commission in a better position to assist courts in striking an appropriate balance between competing concerns.

The Commission will consider filing briefs at the trial court level in private securities actions on, among other things, motions to dismiss or for summary judgment on complaints or defenses and motions for sanctions. The Commission will also consider filing briefs in securities class actions on such issues as class certification, notices to the class, settlements, attorney fee awards and other issues under Rule 23 of the Federal Rules of Civil Procedure. It will generally not be feasible for the Commission to participate on issues that require a resolution of factual disputes or involve the review of an extensive factual record. Parties, class members and courts seeking to bring to the Commission's attention cases in which Commission involvement might be appropriate should contact the Commission's General Counsel. ### RULES AND RELATED MATTERS

The Commission has issued a release proposing for public comment a new rule and form under the Investment Advisers Act of 1940 that would require certain investment advisers to provide clients with an annual report regarding their use of client brokerage, including their receipt of research and other services in exchange for that brokerage. # ENFORCEMENT PROCEEDINGS

### ORDER INSTITUTED

The Commission today announced the issuance of an Order Instituting Public Proceedings, Making Findings and Imposing Sanctions (Order) against Edward J. Barter pursuant to an Offer of Settlement. The Order bars Barter from association with any broker, dealer, investment adviser, investment company or municipal securities dealer for a period of one year from the date of the Order.

On December 1, 1994, without admitting or denying the allegations of a Complaint the Commission had filed in the United States District Court for the Southern District of New York, Barter consented to the entry of a Final Judgment of Permanent Injunction. The Commission's Complaint alleged that from in or about August 1987 through in or about October 1987, Barter and others engaged in a fraudulent scheme to manipulate the prices of the common stock of Big O Tires, Inc., Cliff Engle, Ltd., Flores de New Mexico, Inc., Fountain Powerboat Industries, Inc. and TS Industries, Inc. # PROPOSED RULE CHANGES

The <u>National Association of Securities Dealers</u> filed a proposed rule change (SR-NASD-95-08) to extend the Interim SOES Rules (except the reduction of the maximum order size from 1,000 shares to 500 shares) through October 2, 1995. Currently, the Interim SOES Rules are scheduled to expire on March 27, 1995. Publication of the proposal is expected in the <u>Federal Register</u> during the week of February 20. (Rel. 34-35364)

The Commission received a proposed rule change filing (SR-CBOE-95-04) by the <u>Chicago Board Options Exchange</u> that would grant two Floor Officials the authority to call for a trading rotation and to delay the commencement of an opening rotation if the Floor Officials believe this will aid in producing a fair and orderly market. In addition, Order Book Officials would be authorized to deviate from the rotation order and manner which the Floor Procedures Committee may have established, as long as two Floor Officials first approve such a deviation. Further, if the appropriate Floor Procedures Committee has not established the rotation order and manner for the options under its purview in a particular situation, then the Order Book Official may determine the order and manner of rotation. Publication of the notice is expected in the Federal Register during the week of February 20. (Rel. 34-35369)

The National Association of Securities Dealers filed a proposed rule change (SR-NASD-95-06) to amend Part III, Section 32 of the Code of Arbitration Procedure. The amendment would amend Section 32(c) of the Code to increase the amount of time before a hearing where the parties are required to exchange documents from 10 to 20 days. Publication of the proposal is expected in the <u>Federal Register</u> during the week of February 20. (Rel. 34-35370)
