ENFORCEMENT PROCEEDINGS

REGISTERED REPRESENTATIVE THOMAS BOWES CENSURED

The Commission has instituted public administrative proceedings under the Securities Exchange Act of 1934 (Exchange Act) and the Investment Advisers Act of 1940 (Advisers Act) against Thomas J. Bowes (Bowes), a registered representative at Prudential Securities Inc. (Prudential).

The Order Instituting Public Proceedings alleges that, between January 1992 and September 1993, Bowes had entered into an arrangement with Mountain Capital Management, Inc. (Mountain Capital), an investment advisory firm in Norwood, New Jersey, and its owner, Neil T. Monteleone, whereby Mountain Capital and Monteleone received from Bowes fifty percent of the commissions generated on each securities transaction executed at Prudential on behalf of their investment advisory clients. Monteleone and Mountain Capital received over \$10,000 pursuant to this scheme in addition to the advisory fees they charged to their clients for their advisory services. The Commission further alleges that Monteleone and Mountain Capital did not disclose the existence of this arrangement to their advisory clients, in violation of Section 17(a) of the Securities Act, Section 10(b) of the Exchange Act and Rule 10b-5 thereunder, and Section 206 of the Advisers Act and that Bowes' participation in the commission sharing arrangement aided and abetted Monteleone and Mountain Capital's violations of Section 206 of the Advisers Act.

Simultaneously with the institution of these proceedings, the Commission accepted an offer of settlement by Bowes, under which he consented, without admitting or denying the findings, to the entry of the Findings and Order of the Commission (Order). The Order orders Bowes to cease and desist from causing any violation and any future violation of Section 206 of the Advisers Act; and censures him. (Rel. 34-35352)

BROKER-DEALER REGISTRATION OF SOUTHERN CALIFORNIA SECURITIES, INC.

On February 10, the Commission instituted a public administrative proceeding pursuant to Sections 15(b) and 19(h) of the Securities Exchange Act of 1934 (Exchange Act) against Southern California Securities, Inc. (SCSI). The Order revokes SCSI's registration as a broker-dealer.

SCSI, without admitting or denying the Commission's findings, consented to the issuance of an Order by the Commission that finds that SCSI was permanently enjoined from future violations of the antifraud provisions of Section 17(a) of the Securities Act of 1933 (Securities Act) and Sections 10(b) and 15(c) of the Exchange Act and Rules 10b-5 and 15c1-2 thereunder. The Commission's complaint filed in the civil injunctive action alleges, among other things, that SCSI and the other named defendants engaged in the fraudulent offer and sale of securities in the form of interests in oil and gas limited partnerships in violation of Section 17(a) of the Securities Act and Sections 10(b) and 15(c) of the Exchange Act and Rules 10b-5 and 15c1-2 thereunder by misusing and misappropriating at least \$1.4 million of the \$3.4 million raised from January 1993 through June 1994; failing to transfer to the partnerships interests in oil and gas properties purportedly purchased for the partnerships; failing to invest approximately 9% of the offering Government Obligations, proceeds in U.S. contrary to oral representations and representations in the offering documents; and failing to disclose that SCSI and the other named defendants were supplementing purported oil and gas revenue by advancing funds from various sources to pay investors the represented 12% return. CIVIL ACTION FILED AGAINST EDWARD ELLIS, SR.

On February 15, the Commission filed a complaint in the U.S. District Court for the Eastern District of Pennsylvania against Edward V. Ellis, Sr. (Ellis) alleging violations of the antifraud and registration provisions of the securities laws. The complaint seeks permanent injunctive relief and the imposition of a civil penalty. The complaint alleges that between 1988 and 1993, Ellis defrauded investors by selling \$1.6 million in unregistered securities of two companies he owned and controlled to 350 investors. Ellis misrepresented to investors that he planned to open hundreds of franchises and would use the investment proceeds to promote and operate the stores.

In reality, Ellis used investors' proceeds for personal expenses such as automobiles, homes, and college tuition. Ellis is currently serving a 30-month sentence based on the above misconduct.

Simultaneously with the filing of the Commission's complaint, Ellis consented, without admitting or denying the allegations contained in the complaint, to the entry of an order permanently enjoining him from future violations of the charged provisions and acknowledging the appropriateness of a civil penalty, but not ordering the same based upon demonstrated inability to pay. INVESTMENT COMPANY ACT RELEASES

OFFITBANK VARIABLE INSURANCE FUND, INC., ET AL.

An order has been issued under Section 6(c) of the Investment Company Act exempting Offitbank Variable Insurance Fund, Inc. (Fund) and Offitbank (collectively, Applicants) from the provisions of Sections 9(a), 13(a), 15(a) and 15(b) of the Act, and Rules 6e-2(b)(15) and 6e-<math>3(T)(b)(15) thereunder. The order provides exemptions to the extent necessary to permit shares of any current or future investment series of the Fund to be sold to and held by the separate accounts funding variable annuity and variable life insurance contracts issued by certain affiliated and unaffiliated life insurance companies. HOLDING COMPANY ACT RELEASES

EASTERN UTILITIES ASSOCIATES, ET AL.

An order has been issued authorizing EUA Cogenex Corporation (Cogenex), a wholly owned subsidiary of Eastern Utilities Associates, a registered holding company, and EUA Cogenex Canada Corporation and Northeast Energy Management, Inc., wholly owned subsidiaries of Cogenex, to engage in providing energy management services and demand side management services, without regard to any limitation on the amount of revenues attributable to customers outside the New York/New England area. (Rel. 35-26232)

SELF-REGULATORY ORGANIZATIONS

DELISTINGS GRANTED

An order has been issued granting the application of the <u>Boston Stock</u> <u>Exchange</u> to strike from listing and registration Aqua Vie Beverage Corporation, Common Stock, \$.001 Par Value. (Rel. 34-35365)

An order has been issued granting the application of the <u>American Stock</u> <u>Exchange</u> to strike from listing and registration Guardian Bancorp, Common Stock, No Par Value. (Rel. 34-35377)

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change filed by the <u>New York</u> <u>Stock Exchange</u> (SR-NYSE-94-42) to require corporations that distribute interim reports to shareholders to distribute such reports to both registered and beneficial shareholders. (Rel. 34-35373)

PROPOSED RULE CHANGES
