ENFORCEMENT PROCEEDINGS

JOHN WALLACE CENSURED

The Commission announced the entry of an Order Instituting Proceedings, Making Findings and Imposing Remedial Sanctions against John L. Wallace, an equity portfolio manager since 1990. The findings and sanctions are in accordance with an Offer of Settlement submitted by Wallace whereby he consented to the Order.

Pursuant to the Order and Offer, the Commission found that between April 1993 and December 31, 1993, Wallace failed to report brokerage accounts and transactions in accounts in which he had a direct or indirect beneficial ownership. Such failure resulted in Wallace's violating Section 17(j) and Rule 17j-1(c) of the Investment Company Act and Section 204 and Rule 204(a)(12) of the Investment Advisers Act.

The Order censured Wallace and imposed \$20,000 in penalties taking into consideration the fact that Wallace had been sanctioned by his employer and had forfeited over \$200,000 in options and bonuses in compliance with his employer's sanctions. (Rel. IA-1470; IC-20904)

COMPLAINT FILED AGAINST MICHAEL MORSE, WTF, LTD. AND RHEIMS INVESTMENTS, LTD.

The Commission announced that on February 27 a civil complaint was filed in New York against Michael J. Morse, WTF, Ltd., a South Carolina corporation owned by Morse, and Rheims Investments, Ltd., a Bahamian entity beneficially owned by Morse, seeking injunctive relief, disgorgement and civil penalties.

The complaint alleges that during July and August 1994, Morse, through WTF and Rheims, placed sell orders in cash accounts for the common stock of six different companies without owning the stock sold. The complaint alleges that Morse maintained the cash accounts at nine broker-dealers and that Morse made various misrepresentations and omissions to these broker-dealers.

Specifically, the complaint alleges that Morse failed to tell the broker-dealers that he did not own the stock he sold; falsely told the broker-dealers that the stock would be forthcoming to settle the trades; and falsely supplied the various broker-dealers with inconsistent and fraudulent information regarding his net worth and annual income. The complaint alleges that, as a result, the broker-dealers lost in excess of \$13.5 million. [SEC v. Michael Morse, et al., USDC, SDNY, 95 Civ. 1352, JGK] (LR-14423)

SEC v. UNITED COMMUNICATIONS, LTD., ET AL.

On February 27, the Commission filed a complaint in United States District Court for the District of Columbia alleging that defendants had violated the antifraud and issuer and broker-dealer registration provisions of the federal securities laws, and seeking an injunction, an asset freeze and other relief.

The complaint also named TechniVision, Inc. as a relief defendant. The Commission, simultaneously, accepted TechniVision's offer of settlement wherein TechniVision offered to disgorge \$7 million, representing money which it had received from defendant United Communications.

The Commission alleges that the defendants, other than TechniVision, the relief defendant, engaged in a fraudulent scheme which induced approximately three thousand investors nationwide to invest over \$40 million in "membership units" in limited liability companies, which purportedly were developing wireless cable television systems in Utica, New York; Corpus Christi, Texas; Dayton, Ohio; and Auburn, Alabama. The defendants misrepresented and omitted material information concerning the returns which investors could expect and the risks to which investors would be subject. [SEC v. HOLDING COMPANY ACT RELEASES

COLUMBUS SOUTHERN POWER COMPANY, ET AL.

A notice has been issued giving interested persons until March 20 to request a hearing on a proposal by Columbus Southern Power Company, Kentucky Power Company and Ohio Power Company (Companies), electric public utility subsidiary companies of American Electric Power Company, Inc., a registered holding company, to issue and sell its debentures in respective aggregate principal amounts of up to \$80 million, \$65 million and \$90 million; or to, among other things, borrow money from and make equity contributions to newly organized subsidiaries formed solely for the purpose of issuing and selling preferred securities or partnership interests for the Companies in respective aggregate amounts of up to \$75 million, \$60 million and \$85 million, through December 31, 1997. THE COLUMBIA GAS SYSTEM, INC.

A notice has been issued giving interested persons until March 20 to request a hearing on a proposal by The Columbia Gas System, Inc. (Columbia), a registered holding company. Columbia proposes to make a loan of no more than \$4.3 million to the Employees' Thrift Plan of Columbia Gas System. (Rel. 35-26237)

ENTERGY CORPORATION, ET AL.

A notice has been issued giving interested persons until March 20 to request a hearing on a proposal by Entergy Corporation (Entergy), a registered holding company, to invest up to \$350 million in its wholly owned nonutility subsidiary company, Entergy Enterprises, (Enterprises), for its use in preliminary development activities for potential investments by Entergy in various projects; provision of consulting services to unaffiliated companies and associate companies primarily in the areas of power generation, transmission distribution and related operations; provision of management administrative support services (Administrative Services) to certain of Enterprises' associate companies; provision of operations and maintenance services (O&M Services), directly or indirectly, unaffiliated third parties and affiliated power projects; and other related transactions. Enterprises also requests that the Commission release its reservation of jurisdiction and permit Enterprises to provide Administrative Services to associate companies that are exempt wholesale generators and foreign utility companies. In addition, Enterprises proposes to charge fair market value for Administrative and O&M Services provided to certain associate companies and requests an exemption from Rules 90 and 91.
