COMMISSION ANNOUNCEMENTS

CHAIRMAN LEVITT ANNOUNCES TWO INITIATIVES TO IMPROVE INVESTOR PROTECTION: CREATES OFFICE OF COMPLIANCE INSPECTIONS AND EXAMINATIONS TO COORDINATE SEC INSPECTION PROGRAMS; CREATES OFFICE OF MUNICIPAL SECURITIES

Chairman Levitt today announced that the Commission has consolidated its examination and inspection programs into one, new office, called the Office of Compliance Inspections and Examinations (OCIE.) The Office will be responsible for conducting and coordinating all SEC inspection programs nationwide. He also announced the Commission's appointment of the Office of Municipal Securities to provide coordination and expertise on the varied initiatives related to the municipal securities market. Together, these reorganizations will improve operations in the Commission's oversight and regulatory functions, enabling it to be more responsive to both the industry and investors.

Chairman Levitt announced that he has appointed Lori Richards, currently Executive Assistant to the Chairman, to serve as Director of the OCIE, and Paul Maco, currently an Attorney Fellow in the Office of the General Counsel, to lead the Office of Municipal Securities. (Press Rel. 95-50)

CORRECTION TO AMENDMENTS TO RULES ON ORGANIZATION AND PROGRAM MANAGEMENT

The Commission has issued a correction to Release No. 34-35483, noticed in the Digest on March 15, amending its rules on organization and program management. The correction involves an amendment to those rules that was inadvertently omitted from the original release. (Rel. 34-35483A)

ENFORCEMENT PROCEEDINGS

ADMINISTRATIVE PROCEEDINGS INSTITUTED, FINDINGS MADE AND SANCTION IMPOSED AGAINST ROBERT MCATEE

The Commission has issued an Order Instituting Public Administrative Proceedings Pursuant to Sections 15(b) and 19(h) of the Securities Exchange Act of 1934, Making Findings and Imposing Remedial Sanctions (Order) against Robert L. McAtee (McAtee) of Belton, Missouri. McAtee

was associated as a vice-president and sales agent with Premier Financial Services, Inc., an unregistered broker-dealer. McAtee submitted, and the Commission accepted, an Offer of Settlement whereby he consented, without admitting or denying the findings contained therein except as to jurisdiction, to the entry of this Order.

The Order finds that from March 1993 and continuing through May 1993, McAtee willfully violated the registration provisions by offering and selling to the public certificates issued by Premier Benefit Capital Trust (PBCT) when no registration statement was filed or in effect. The Order also finds that McAtee willfully violated the antifraud provisions, in that, in connection with the offer and sale of the certificates, McAtee distributed various offering brochures and made verbal statements to investors that misrepresented and omitted material facts regarding PBCT, its operations, its officers and trustees, the risks involved in the investment, and the use of investors' funds.

The Commission, based upon the findings and McAtee's consent, barred McAtee from association with any broker, dealer, municipal securities dealer, investment company or investment adviser provided, however, that after a period of three years subsequent to the entry of this Order he has a right to apply to become so associated. BURNETT GREY & COMPANY, INC. ORDERED TO CEASE AND DESIST AND ITS REGISTRATION REVOKED

On March 15, the Commission made findings and entered an order imposing remedial sanctions and a cease and desist order (Order) by default against Burnett Grey & Company, Inc. (Burnett Grey), a registered The Order stated that Burnett Grey failed to file an broker-dealer. answer or other pleading in response to the order that instituted administrative proceedings and was therefore in default. found that from May 1993 through July 1993 and from October 1993 through February 1994, Burnett Grey failed to maintain the required minimum net capital in violation of to maintain the required minimum net capital in violation of Section 15(c)(3) of the Securities Exchange Act and Rule 15c3-1. The Order also found that from June 1993 through February 1994, Burnett Grey kept inaccurate books and records, filed inaccurate, incomplete and/or untimely FOCUS reports, and failed to provide timely telegraphic notice in violation of Section 17(a) of the Securities Exchange Act and Rules 17a-3, 17a-5 and 17a-11. Burnett Grey was ordered to cease and desist from committing or causing violations of these provisions. The Order also revoked Burnett Grey's registration as a broker-dealer. (Rel. 34-35490)

HOLDING COMPANY ACT RELEASES

CENTRAL AND SOUTH WEST CORPORATION, ET AL.

An order has been issued authorizing Central and South West Corporation (CSW), a registered holding company, and its subsidiary companies, Central and South West Services, Inc., Central Power and Light Company, Public Service Company of Oklahoma, Southwestern Electric Power Company, West Texas Utilities Company and Transok, Inc., to continue to issue, sell and acquire short-term notes under their short-term borrowing program and the CSW System Money Pool in aggregate outstanding principal amounts of up to \$1.2 billion, through March 31, 1997. THE COLUMBIA GAS SYSTEM, INC., ET AL.
